# Pacific Law Materials in Wellington

Work in the Pacific Legal Studies programme in 1983 made it clear to all involved that not only were Pacific legal materials relatively few and far between but also that finding the available materials readily was a task of some difficulty. This list was compiled as an internal document to provide a first step to materials relevant to a specific research project to save successive researchers some of the time otherwise spent in locating the available materials in Wellington. The list was prepared during the summer of 1983 on the initiative and under the direction of A. H. Angelo. Brendon Whiteman was responsible for the collection and collation of the data. The project was assisted by a grant from the V.U.W. Internal Research Committee and that grant is here gratefully acknowledged. The material is presented not as a definitive or exclusive bibliography but as an initial reference guide to those working with pacific materials in Wellington. Publication in this Review was seen as the easiest way for others in New Zealand to have access to the list. Where local collections are small, it is hoped that this list will go some way towards maximizing the use of the resources held in Wellington. Primarily the materials referred to are those that can be found in the Victoria University of Wellington Library (V.U.W.) Additionally however, some Pacific law related materials that are available in the public libraries and the court libraries in Wellington are noted. Specifically, primary source materials available in the General Assembly Library (G.A.), the Ministry of Foreign Affairs Library (M.F.A.), and the Alexander Turnbull Library (Turnbull) are listed here.
