Order

1 Title and commencement

- (1) This order may be cited as the Maritime Transport Act (Conventions) Order 1994.
- (2) This order shall come into force on 1 February 1995.

2 Specified international conventions and specified amendments declared to be conventions for purposes of Parts 1 to 15 of Maritime Transport Act 1994

- (1) Every international convention specified in the Schedule—
 - (a) relates to maritime transport; and
 - (b) is an instrument to which New Zealand is a party; and
 - (c) is declared to be a convention for the purposes of Parts 1 to 15 of the Maritime Transport Act 1994.
- (2) Every amendment specified in the Schedule that is an amendment to an instrument referred to in subclause (1) is declared to be a part of that instrument for the purposes specified in subclause (1)(c).

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 February 1995, declares certain maritime conventions to which New Zealand is a party, together with specified amendments, to be conventions for the purposes of Parts 1 to 15 of the Maritime Transport Act 1994.

Date of notification in *Gazette*: 1 December 1994.

Notes

1 *General*

This is a consolidation of the Maritime Transport Act (Conventions) Order 1994 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

2 *Legal status*

A consolidation is taken to correctly state, as at its stated date, the law enacted or made by the legislation consolidated and by the amendments. This presumption applies unless the contrary is shown.

Section 78 of the Legislation Act 2019 provides that this consolidation, published as an electronic version, is an official version. A printed version of legislation that is produced directly from this official electronic version is also an official version.

3 *Editorial and format changes*
