E IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

- 1. The Short Title of this Act shall be "The Assaults on Con-Short Title: stables Act, 1873."
- 2. Whosoever shall assault resist or wilfully obstruct, or incite Persons assaulting any person to assault resist or obstruct, any peace officer in the due or obstructing, or inciting others to execution of his duty, or any person acting in aid of such officer, shall assault or obstruct be liable, on summary conviction, to a penalty of not exceeding ten peace officers, liable to penalty of £10, pounds, or, in the discretion of a Resident Magistrate or any two or, in discretion of Justices before whom he is convicted, may be imprisoned for any imprisonment, with term not exceeding two months, with or without hard labour.

Any person who shall assault resist or wilfully obstruct any peace officer in the execution of his duty, or any person acting in aid of such officer, may be taken into custody without warrant by any peace officer; and every person so arrested shall be taken as soon as convenient before some Justice of the Peace, to be dealt with according to law.
