

- An Act to alter and amend "The Customs Tariff Act Title. 1866." [10th November 1871.]
- E IT ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows:
- 1. The Short Title of this Act shall be "The Customs Tariff Act Short Title.
- 2. On and after the tenth day of November one thousand eight New duties on hundred and seventy-one there shall be levied collected and paid articles herein to Her Majesty her heirs and successors on the articles next hereinafter mentioned on importation into New Zealand or on being cleared from any warehouse for home consumption the several Duties of Customs following (that is to say) -

Grain and Pulse of every kind not otherwise enumerated in "The Customs Tariff Act 1866" or "The Customs Tariff Amendment Act 1867" or this Act d. . the 100 lbs.

Grain and Pulse of every kind not otherwise enumerated in the said last-mentioned Acts or this Act when ground or in any way prepared or manufactured

3. On and after the tenth day of November one thousand eight Increased duties on hundred and seventy-one in lieu of the Duties of Customs chargeable certain articles. under "The Customs Tariff Act 1866" on the articles next hereinafter mentioned there shall be levied collected and paid to Her Majesty her heirs and successors upon the articles next hereinafter mentioned on importation into New Zealand or on being cleared from any warehouse for home consumption the several duties following (that is to say)

"Customs Regulation Act 1858" to apply. 4. The Duties of Customs imposed by this Act shall be raised levied collected and paid under the provisions of "The Customs Regulation Act 1858" and "The Customs Regulation Act Amendment Act 1868" and subject also to all such provisions and regulations as may for the time being be in force for the collection management and receipt of the duties of import in the Colony of New Zealand.

5. The sections of "The Customs Tariff Act 1866" numbered

5. The sections of "The Customs Tariff Act 1866" numbered four five seven nine ten and twelve shall be deemed to be incorporated in this Act.

6. Notwithstanding the provisions of "The South Sea Islands Drawbacks Act 1870" there shall be allowed upon the exportation to any port or place out of New Zealand of goods imported into the Colony except on the goods excepted therein a drawback of the duty paid thereon but such drawback shall only be paid subject to all the conditions and provisions relating to drawbacks contained in the said above-mentioned Act and in "The Customs Regulation Act 1858."
