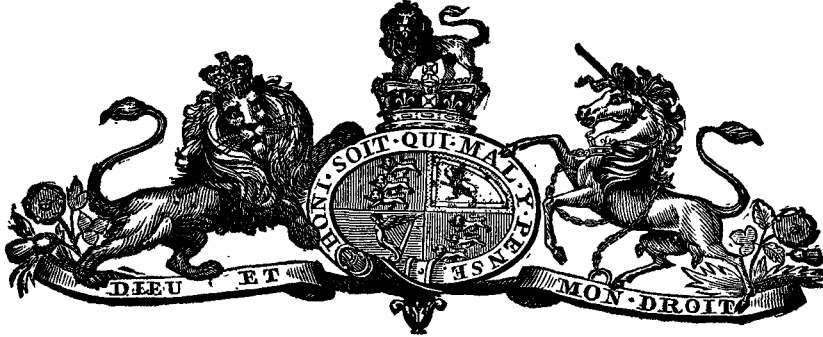

AN ACT to make provisions for the Amendment and Continuan-
ce of "The Maori Representation Act, 1867."
[25th October, 1872.]

WHEREAS by "The Maori Representation Act, 1867," (herein-
after called "the said Act,") it was enacted that the said Act
should continue in force for five years after the passing there-
of, and it is expedient to prolong the continuance thereof as so
amended:

BE IT THEREFORE ENACTED by the General Assembly of New
Zealand in Parliament assembled, and by the authority of the same,
as follows:—

1. The Short Title of this Act shall be "The Maori Representation
Act Amendment and Continuance Act, 1872."

2. The said Act, as amended by this Act, shall be and continue in
force until the tenth day of October, one thousand eight hundred and
seventy-seven: Provided that in case this Act shall not have been
passed by the General Assembly before the expiration of the said Act,
then, upon the passing of this Act, the said Act shall be deemed to
be and to have been revived and continued as amended by this Act
from the expiration of the said Act.

3. Wherever in the eighth and ninth sections of the said Act
it is provided that the Governor may make any Proclamation, or do

under 8th and 9th sections of the said Act, as occasion requires.

any act under either of those sections, it is hereby declared that he shall have the power to make such Proclamation or do such act from time to time, and as often as occasion shall require.

4. The person who at the time of the making and publication of any Proclamation altering the boundaries of any Maori Electoral District is the Member of the House of Representatives for such district, shall (if in all other respects duly qualified) be and be deemed to be the Member for such one of the Maori Electoral Districts affected by such alteration as the Governor shall in and by any such Proclamation appoint, as if such Member had been originally elected for such Electoral District so altered as aforesaid.

5. Subject to the amendments made by this Act, all and singular other the provisions of the said Act shall remain and continue in force, and the said Act and this Act shall, subject as aforesaid, be read and construed as one Act; and the expression "this Act" where used in the said Act, shall mean the said Act as amended by this Act.

6. No Member elected under the provisions of this Act to serve in the House of Representatives, and no Maori Member who shall be summoned to the Legislative Council, shall be capable of being appointed to any office of emolument under the General Government of the Colony so long as he may be a Member of the General Assembly. And if any such Member of either branch of the Legislature shall at the time of his being summoned or elected hold any such office of emolument as aforesaid, the salary or emolument of such office shall neither be increased nor diminished during such time as he may be a Member of the General Assembly: Provided that the provisions of this clause shall not apply to the holding a seat in the Executive Council, or holding an appointment as adviser or assessor of or in connection with the Executive Council, and receiving salary only in respect of such seat or such appointment—such seat or appointment being held on the ordinary tenure of responsible government.
