**An Act to grant certain sums of Money to Her Majesty for Native Purposes.**  
[15th September, 1862.]

**W**HEREAS upon the assumption of the Government of New Zealand by Governor Sir George Grey His Excellency was pleased to propose a plan under which the sum of about Fifty Thousand Pounds per annum should be applied to certain purposes of Native government and otherwise of which sum part should be contributed by the Government of New Zealand and part by the Imperial Government And whereas by Instructions signified through one of Her Majesty's Principal Secretaries of State bearing date 26th May 1862 Her Majesty's Government was pleased to approve of the said proposal subject to certain conditions in the said Instructions set forth And whereas for the purpose of giving effect to so much of the said plan as relates to the appropriation of money for the objects contemplated by the Governor and by Her Majesty's Government it is expedient to grant to Her Majesty the several sums of money hereinafter mentioned:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows:

I. The Short Title of this Act shall be the "Native Purposes Appropriation Act 1862."

II. There shall be paid to Her Majesty from the 30th day of June 1862 until the 30th day of June 1865 out of the Revenue arising from Taxes Duties Rates and Imposts levied under any Act or Acts of the General Assembly the several yearly sums hereinafter mentioned.

III. In addition to the sum of Seven Thousand Pounds now payable yearly to Her Majesty for Native purposes under the provisions of the Civil List Act 1858 there shall be paid to Her Majesty the yearly sum of Nineteen Thousand Pounds

to be expended for Native purposes in such manner as the Governor shall direct.

Grant of Five Pounds per head for Troops.

IV. There shall also be paid to Her Majesty by way of contribution by the Colony towards the expenses of the Queen's Forces supplied for its defence the yearly sum of Five Pounds for every Officer and soldier of Her Majesty's Army employed on service in New Zealand. And for the purpose of computing the number of men in respect whereof this payment shall be made it shall be lawful for the Governor to take during each period of twelve months the number of Officers and soldiers at the date of each "Monthly State" furnished by the Officer in command of Her Majesty's troops and at the end of each period to strike the average number over the whole twelve months and the average number so struck shall be the number in respect whereof the yearly payment of Five Pounds per man hereby granted shall be made.

Governor may expend contribution for troops upon Native purposes.

V. It shall be lawful for the Governor in each year after the sum of Nineteen Thousand Pounds first hereinbefore granted and the sum of Seven Thousand Pounds on the Civil List as aforesaid (making together the total sum of Twenty-six Thousand Pounds) shall have been expended to appropriate such part of the yearly payment for troops secondly hereinbefore granted as the Governor shall direct to be expended for such Native purposes as to him shall seem fit.

Grants to be exclusive of Seven Thousand Pounds for Native Schools.

VI. The yearly grants hereby made shall not interfere with but be exclusive of the yearly grant of Seven Thousand Pounds now payable to Her Majesty for the support of Native Schools under the provisions of the "Native Schools Act 1858."
