An Act to confirm and validate certain subordinate legislation

[9 September 1999]

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Subordinate Legislation (Confirmation and Validation) Act 1999.

PART 1

CONFIRMATIONS AND VALIDATIONS

2. Biosecurity Act 1993—The following orders are confirmed:

- (a) The Biosecurity (Bovine Tuberculosis–Otago Land Levy) Order 1998 (S.R. 1998/442);
- (b) The Biosecurity (Bovine Tuberculosis–Cattle Levy) Order 1998 (S.R. 1998/457).

3. Commodity Levies Act 1990—The following orders are confirmed:

- (a) The Commodity Levies (Winemaking Grapes) Order 1998 (S.R. 1998/349);
- (b) The Commodity Levies (Eggs) Order 1999 (S.R. 1999/56);

- (c) The Commodity Levies (Nashi Asian Pears) Order 1999 (S.R. 1999/221).

4. Customs and Excise Act 1996—The following orders are confirmed:

- (a) The Excise and Excise-Equivalent Duties (Tobacco Products Indexation) Amendment Order 1998 (S.R. 1998/337);
- (b) The Customs Import Prohibition (Trout) Order 1998 (S.R. 1998/436);
- (c) The Customs Import Prohibition (Asbestos) Order 1999 (S.R. 1999/23);
- (d) The Excise and Excise-Equivalent Duties (Alcoholic Beverages Indexation) Amendment Order 1999 (S.R. 1999/114);
- (e) The Customs Export Prohibition Amendment Order 1999 (S.R. 1999/270);
- (f) The Customs Import Prohibition Order 1999 (S.R. 1999/271).

5. Primary Products Marketing Act 1953—The Raspberry Marketing Authorities (Dissolution) Regulations 1999 (S.R. 1999/223) are confirmed.

6. Social Security Act 1964—The following orders are validated and confirmed:

- (a) The Social Security (Asset Limits) Order 1998 (S.R. 1998/309);
- (b) The Social Security (Rates of Benefits and Allowances) Order 1999 (S.R. 1999/58).

7. Tariff Act 1988—The Tariff (Zero Duty) Amendment Order 1999 (S.R. 1999/131) is validated and confirmed.

8. War Pensions Act 1954—The War Pensions (Rates of Pensions and Allowances) Order 1999 (S.R. 1999/61) is validated and confirmed.

9. Effect of validations—The validations effected by sections 6, 7, and 8 are for the purpose only of preventing the expiry of the enactments validated; and do not—

- (a) Express an intention to give legislative force to the provisions of those enactments; or
- (b) Apply to any reason for invalidating any of those enactments; or

- (c) Override any presumption that would otherwise apply to any of those enactments.

PART 2

REPEAL

10. Repeal—The Subordinate Legislation (Confirmation and Validation) Act 1998 is repealed.
