An Act to amend "The Licensing Act 1873 Amend-Title. ment Act, 1874." [18th October, 1875.]

E IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. The Short Title of this Act shall be "The Licensing Short Title. Amendment Act, 1875."

2. The proviso to the thirteenth section of "The Licensing Act Repeal of proviso to 1873 Amendment Act, 1874," is hereby repealed, and in lieu thereof Licensing Act 1873 it is provided that no Court shall grant a license to any applicant at Amendment Act, any such meeting if such applicant or any person in his behalf or in 1874." his interest has at any previous licensing meeting (whether within the same district or in any other district) been refused a license on the ground that such applicant or such person as aforesaid was an unsuitable person to hold a license under the said Act.

3. Notwithstanding anything contained in "The Licensing Act No license shall 1873 Amendment Act, 1874," no wholesale license or brewer's license be issued unless appropriate by the shall be issued to any person by any Provincial Treasurer or any other Licensing Court. person under the tenth section of the said Act, to take effect within the respective districts defined under the said Act and mentioned in the Schedule hereto, or in any other district which may hereafter be defined in lieu of or in substitution for the districts mentioned in the said Schedule, unless the issue of such license shall first have been approved of by the Licensing Court having jurisdiction at the place or places where it is intended such license shall take effect.

Licensing Amendment.

The production of a certificate in writing under the hand of the Chairman of such Licensing Court as aforesaid, to the effect that such Court approves of the issue of the license therein mentioned to the person to be named therein, shall be sufficient evidence that the Court approves of the issue of such license.

Licensee to accommodate travellers; not to supply intoxicated person with liquor.

4. Any holder of a license refusing either personally or through any one acting on his behalf, except for some valid reason, to supply lodging, meals, or accommodation to travellers, or supplying intoxicating liquors to a person already in a state of intoxication, shall for each offence be liable on conviction to forfeit and pay any sum not exceeding ten pounds.

Schedule.

SCHEDULE.

Mongonui District.

Bounded towards the North and North-east by high watermark of the sea and Whangaroa Harbour from Cape Mania Van Diemen to the mouth of the Iwitaua Creek; towards the South-east by the Iwitaua Creek aforesaid, part of the eastern and southern boundaries of the Parish of Kohumaru, the Koho Wainui River, the south-eastern and part of the south-western boundaries of the Maungataniwha Block to the westernmost angle of the said block, and thence in a straight line bearing westerly to the sea at the North Head of Herekino Harbour; and towards the West by high watermark of the sea from the North Head of Herekino Harbour aforesaid to Cape Maria Van Diemen, the place of commencement.

HOKIANGA DISTRICT.

Bounded towards the North by the Mongonui District from the sea at the North Head of the Herekino Harbour to the south-westernmost angle of the Maungataniwha Block; towards the East by a straight line from the said angle to the summit of a hill at Okaihau, called "Te Pare o Kawa;" thence in a straight line to the south-western point of Omapere Lake; thence by a straight line to the summit of the north-eastern peak of the Tutumoe Range, and continuing along that range to Mongonui Bluff; towards the South-west by high watermark of the sea from Mongonui Bluff aforesaid to the North Head of Herekino Harbour.

BAY OF ISLANDS DISTRICT.

Bounded towards the North and North-west by the Mongonui District from the mouth of the Iwitaua Creek to the south-westernmost angle of the Maungataniwha Block; towards the West by the Hokianga District; towards the South by a straight line from the most eastern peak of the Tutumoe Range to the confluence of the Wairua and Mangaharuru Rivers; thence by a straight line to the North Head of Tutukaka Harbour; and towards the East and North-east by high watermark of the sea and Whangarei Harbour from the North Head of the Tutukaka Harbour to the mouth of the Iwitaua Creek aforesaid; including the Cavalli, Moturoa, and adjacent Islands, and also including the Orohia and adjacent Islands in the Bay of Islands.
