

An Act to repeal "The Vaccination Act 1863" and Title. to make other provision in lieu thereof.

[14th November 1871.]

HEREAS it is expedient to repeal "The Vaccination Act 1863" Preamble. and to make other provision in lieu thereof:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows:

1. The Short Title of this Act shall be "The Vaccination Act Short Title. 1871" It shall come into operation on the first day of March one thousand eight hundred and seventy-two.

2. "The Vaccination Act 1863" is hereby repealed Provided Repeal clause. always that nothing herein contained shall in anywise affect any act or thing lawfully done or any proceedings taken or commenced or any

offence committed under or against the said repealed Act. 3. Any person who after the passing of this Act shall produce or Penalty on person attempt to produce in any person by inoculation with variolous matter small-pox. inoculating with small-pox. or thing impregnated with variolous matter or wilfully by any other means whatsoever produce the disease of small-pox in any person shall be guilty of an offence and shall be liable to be proceeded against

summarily and upon conviction to pay a penalty not exceeding ten pounds or to be imprisoned for any term not exceeding one month.

4. The Colonial Secretary shall at all times cause to be kept at such places as the Governor shall from time to time appoint an adequate supply of pure vaccine lymph for the purpose of furnishing on application and without payment to Public Vaccinators under this Act and to legally qualified Medical Practitioners such reasonable quantities of such matter as by any such Vaccinators or Practitioners may be required. The expense of providing keeping and supplying such vaccine matter shall be defrayed out of moneys to be appropriated for the purposes of this Act by the General Assembly.

5. The Governor may from time to time appoint such and so many qualified persons to be Public Vaccinators under this Act and from time to time remove any person so appointed and appoint another qualified person in his place and every Public Vaccinator shall be paid out of moneys to be appropriated for the purposes of this Act by the General Assembly such annual salary or fees as the Governor shall

from time to time appoint.

6. Any person who shall be a legally qualified Medical Practitioner shall be qualified to be appointed a Public Vaccinator.

And the Governor may from time to time appoint for each Province or other division of the Colony a Medical Practitioner to be a Certifying Officer for the purposes hereinafter mentioned and any person not being a legally qualified Medical Practitioner and whether he shall hold any degree or diploma in medicine or surgery or not whom any such Certifying Officer shall certify to be a competent and proper person to be appointed a Public Vaccinator shall be deemed qualified to be so appointed And for such certificate there shall on the appointment of any person so certified to be a Public Vaccinator be paid to the Certifying Officer out of moneys to be appropriated for the purposes of this Act by the Concept Assembly such propriated for the purposes of this Act by the General Assembly such fee not exceeding three pounds as the Governor shall from time to

7. The Governor may from time to time appoint such places for the performance of vaccination as he shall think fit and may take such performed by Public means as he thinks fit for giving from time to time due notice to the public of the days and hours at which a Public Vaccinator will attend at such places to vaccinate all persons who may then appear and desire

to be vaccinated or whom he may be required to vaccinate.

8. The Governor may from time to time fix the places at which each Public Vaccinator is to attend to perform vaccination and the days and hours at and during which he is to attend there and each Public Vaccinator shall attend at the place and time and during the hours so appointed and there vaccinate without fee or reward other than as provided by this Act all persons who shall attend there and who shall be willing to be vaccinated or whom being apparently under fourteen years of age he shall be required to vaccinate and every Public Vaccinator shall endeavour to ascertain whether the

vaccinations performed by him have been successful.

9. Every Public Vaccinator who shall have performed the operation of vaccination upon any child shall ascertain whether the operation has been successful or not and shall within twenty-one days after the performance of the operation transmit by post or otherwise a certificate under his hand according to the form in the Schedule to this Act annexed or the like effect certifying that the said child has been vaccinated successfully or not as the case may be to the Registrar of Births in the district in which the birth was registered but if such district is not known to him or if the birth of the child

Where a vaccination shall be performed by a Medical Certificate of Practitioner not being a Public Vaccinator appointed under this Act Vaccination by Medical Practitioner the parent or other person causing the child to be vaccinated shall not appointed under submit a certificate according to the form in the Schedule to this this Act.

Every Registrar of Births shall on the first day of January Registrar of Births to and the first day of July in each year send to the Public Vaccinator send list of unvaccinated children to or Vaccinators residing in his district a list of all children whose Public Vaccinator. births are registered by such Registrar and who do not appear by the register kept under this Act to have been vaccinated.

If the teacher of any school which is supported wholly in or Children attending part by grant or from rates or any public funds or by any endowments a public school to be vaccinated. whether Colonial Provincial or Parochial shall have reason to believe that any child attending such school has not been vaccinated he shall give notice to the nearest Public Vaccinator and such Vaccinator shall examine the child and if upon examination he shall be of opinion that such child has not been successfully vaccinated he shall Provided that in the case of persons thereupon vaccinate such child above the age of sixteen the examination shall be conducted by a legally qualified medical practitioner and the person if necessary be vaccinated by him.
