Title	AN ACT to give Effect to the Report of the Commission appointed under Section Ninety-one of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1920. [11th February, 1922.
	BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—
Short Title and commencement.	1. This Act may be cited as the Waikato and King-country Counties Act, 1921-22, and shall come into operation on the first day of April, nineteen hundred and twenty-two.
Act deemed to be a special Act.	2. This Act shall be deemed to be a special Act within the meaning of the Counties Act, 1920.
Otorohanga County constituted.	3. The Otorohanga County is hereby constituted, and shall comprise all that area, being portions of the West Taupo and Waitomo Counties, particularly described in the First Schedule hereto.
Taumarunui County constituted.	4. The Taumarunui County is hereby constituted, and shall comprise all that area, being portion of the West Taupo County, particularly described in the Second Schedule hereto.
Application of Counties Act, 1920.	5. The Counties Act, 1920, shall be in full force in the counties of Otorohanga and Taumarunui.
Awakino and Waitomo Counties abolished, and Waitomo County constituted.	6. (1.) The counties of Waitomo and Awakino are hereby abolished, and the respective County Councils thereof are hereby dissolved. (2.) The area described in the Third Schedule hereto is hereby constituted a new county, to be known as the Waitomo County.

(3.) The provisions of subsections two and three of section ten of the Counties Act, 1920, shall, with the necessary modifications, apply to the said new county in all respects as if the counties of Waitomo and Awakino hereby abolished had been united under the said section ten to form the said new county.

(4.) Sections thirteen and sixteen of the Counties Act, 1920, shall apply as between the Council of the Waitomo County hereinbefore constituted and the Council of any county within the boundaries of which are included any lands heretofore forming part of either of the counties of Waitomo or Awakino hereinbefore abolished in the same manner as if such lands had formed part of the said Waitomo County.

7. (1.) Subject to any adjustment of assets and liabilities pursuant to this Act, the antecedent liabilities within the meaning of the Local Bodies' Finance Act, 1921-22, of the Awakino County Council and of the Waitomo County Council, respectively, shall be deemed to be the antecedent liability of the Council of the Waitomo County constituted by this Act.

Antecedent liabilities of Awakino and Waitomo County Councils to be antecedent liability of new Waitomo County.

(2.) Any rate made and levied by the new Waitomo County Council for the purposes of the Local Bodies' Finance Act, 1921-22, as security for a loan to extinguish, in whole or in part, its antecedent liability under that Act, or for the purpose of providing any annual instalment payable under that Act in reduction or extinction of its antecedent liability, shall, notwithstanding anything to the contrary in that Act, be made separately in respect of the portion of its antecedent liability that was the antecedent liability of the Awakino County Council and in respect of the portion of its antecedent liability that was the antecedent liability of the old Waitomo County Council, and shall be levied accordingly only over the area originally comprised in the Awakino County or the old Waitomo County, as the case may require.

8. (1.) The Governor-General may, by Order in Council, make such provision as he deems necessary for the taking of a poll of ratepayers of the Waitomo County as hereinbefore constituted upon a proposal to determine whether the system of rating on the capital value or the system of rating on the unimproved value shall be in force in the said county.

System of rating in Waitomo County.

(2.) The system of rating declared to be adopted pursuant to such poll shall be in force in the Waitomo County as if the same had been adopted pursuant to the provisions of the Rating Act, 1908.

9. The boundaries of the Kawhia County are hereby altered, and the said county shall comprise all that area described in the Fourth Schedule hereto.

10. The boundaries of the Raglan County are hereby altered, and the said county shall comprise all that area described in the Fifth Schedule hereto.

11. The boundaries of the Waikato County are hereby altered, and the said county shall comprise all that area described in the Sixth Schedule hereto.

12. The boundaries of the Piako County are hereby altered, and the said county shall comprise all that area described in the Seventh Schedule hereto.

13. The boundaries of the Waipa County are hereby altered, and the said county shall comprise all that area described in the Eighth Schedule hereto.

Taupo East and
Taupo West
Counties united.

14. (1.) The counties of East Taupo and West Taupo are hereby abolished, and the area described in the Ninth Schedule hereto, being the area comprised in the said East Taupo County and a portion of the said West Taupo County, is hereby constituted a county, to be known as the Taupo County.

(2.) The Counties Act, 1920, with the exception of section six thereof, shall not apply or be in force in the said Taupo County, and the reference in that section to the counties of West Taupo and East Taupo shall be construed as a reference to the Taupo County constituted by this Act.

(3.) The reference in section twenty-seven of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1916, to the counties of East Taupo and West Taupo shall be construed as a reference to the said Taupo County.

Road districts
abolished.

15. (1.) The Road Boards of the Kakepuku, Parawera, and Roto-orangi Road Districts are hereby dissolved, and the said road districts are hereby merged in the Waipa County as defined in the Eighth Schedule to this Act.

(2.) The Road Boards of the Mangaorongo and Wharepapa Road Districts are hereby dissolved, and the said road districts are hereby merged in the Otorohanga County as constituted by this Act:

Provided that the said Road Boards shall continue to exist for the purposes of section eighteen hereof until the first elected Councillors of the Otorohanga County come into office.

Taupo Road
District constituted.

16. (1.) The area described in the Tenth Schedule hereto, being portion of the Taupo County, is hereby constituted a road district, to be known as the Taupo Road District.

(2.) The Board of the said district shall consist of five members.

(3.) The provisions of subsections four, five, and six of section twenty-seven of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1916, and section one hundred and twenty-two of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1917, shall apply to the Taupo Road District as if the said road district had been constituted under such first-mentioned section.

17. Except as hereinbefore otherwise specially provided, the provisions of the Counties Act, 1920, shall apply in respect of the alterations of boundaries of any counties or the merger of any road districts made or effected by this Act in the same manner in all respects as if such alterations or merger had been made or effected under that Act:

Provided that where, consequent upon the alteration of boundaries of any county, any area is declared by the Governor-General by Proclamation under section twenty-one of the Counties Act, 1920, to be included in any existing riding of such county, it shall not be necessary for an election of Councillors to be held for such riding pursuant to paragraph (c) of section sixty-nine of that Act.

18. Notwithstanding anything in the foregoing provisions of this Act or in any other Act, the local authority which immediately before

the coming into operation of this Act exercised jurisdiction over the area or any part thereof, as the case may be, comprised in each of the Otorohanga and Taumarunui Counties hereinbefore constituted, and in each of the Mangaorongo and Wharepapa Road Districts hereinbefore merged in the said Otorohanga County, shall continue to exercise such jurisdiction during the period between the coming into operation of this Act and the date when the first Councillors of the Otorohanga County or the Taumarunui County, as the case may be, come into office :

Provided that it shall not be lawful for any such local authority to enter into any new contracts or engagements in respect of its exercise of jurisdiction as aforesaid.

FIRST SCHEDULE.

OTOROHANGA COUNTY.

ALL that area of land, situated in the Auckland Land District, bounded by a line commencing at the confluence of the Mangauika Stream with the Waipa River; thence running up the middle of the Waipa River to a point in line with the north-eastern boundary of the Ouruwhero 3E 1 Block; thence to and along that boundary, across the Ouruwhero Road, along the northern boundaries of Ouruwhero Nos. 3E 2, 3E 5, 3o 3, 3o 2c, and 3o 1 Blocks to Section 1, Block X, Puniu Survey District; thence along the western, southern, and eastern boundaries generally of the said Section 1 to and along the southern boundary of Ouruwhero No. 3U Block, along the north-eastern boundary of Ouruwhero No. 3X Block, along the north-western boundary of Tokanui C No. 11 Block; thence by a right line to the north-western corner of Section 2, Block X, Puniu Survey District; thence along the northern boundary of the said Section 2, across a road, along the eastern side of that road to and along the southern boundary of Section 1, Block XI, Puniu Survey District; thence north-easterly along a right line to the junction of the Moerika Stream with the Puniu River; thence up the middle of the Puniu River to its intersection with the north-eastern boundary of Section 1, Block I, Wharepapa Survey District; thence south-easterly along the eastern boundaries of Section 1 aforesaid and Sections 1, 6, and 2, Block II, Wharepapa Survey District; thence north-westerly along the south-eastern boundaries of Sections 3 and 5, Block II, Sections 1, 2, and 3, Block III, Wharepapa Survey District, and the continuation of the latter boundary to the centre of the Waikato River; thence along the middle of the Waikato River to its confluence with the Waipapa Stream; thence up the middle of the said stream to its junction with the Waiteti Stream and the middle of the said Waiteti Stream to its approximate source at Peg CXXX on Survey Office plan 20946 (2) blue; thence south-westerly along a right line of bearing 209° 13', distance 7767 links; thence south-easterly along right lines of bearing 169° 44', distance 10266 links, and of bearing 169° 5', distance 3508 links, as shown on the aforesaid plan; thence along the northern boundary of Maraeroa A No. 3B Block to the south-western boundary of the Rangitoto B Block; thence by the north-eastern boundary of Waitomo County (hereinafter described) to the south-western corner of Section 5, Block I, Orahiri Survey District; thence generally north-easterly along the western boundary of the said Section 5 and a production thereof to the centre of the Awaroa Road; thence by a line along the middle of the said road to the Hauturu Road; and thence along the middle of the Hauturu Road to the Kawhia-Pirongia Road, to a point in line with the north-western boundary of Section 1, Block IX, Pirongia Survey District; thence to and along the said north-western boundary of Section 1 and along the south-eastern boundary of Section 1, Block VI, Pirongia Survey District, and a continuation of the said boundary across a road to Trig. Station on Te Ake-o-Hikopiro; thence along the north-western boundary of the Mangauika 1B No. 2 Section 2 Block to the northern-

most corner of the said block; thence by the southern boundary of Raglan County (as described in the Fifth Schedule to this Act) to the place of commencement.

SECOND SCHEDULE.

TAUMARUNUI COUNTY.

ALL that area of land in the Auckland and Wellington Land Districts bounded towards the north generally by the Waitomo and Taupo Counties (as described in the Third and Ninth Schedules to this Act respectively); on the east generally by Lake Taupo and Taupo County; on the south generally by the middle of the Wanganui River; on the west generally by the Ongarue River to the Waitomo County, the place of commencement: excluding the Borough of Taumarunui.

THIRD SCHEDULE.

WAITOMO COUNTY.

ALL that area of land in the Auckland Land District bounded towards the north generally by a line commencing at a point where the northern boundary of Section 1, Block VI, Marakopa Survey District, intersects the coast-line; thence south-easterly by the said northern boundary of Section 1 to the Kiritehere Road; thence across the said road and southwards by the eastern boundary of Section 28 (scenic reserve) to the point where the said boundary intersects the northern boundary of Section 2; thence following the northern and eastern boundaries of the said Section 2 to the junction with the Ngawaitangirua Road; thence across the said road and along the north-east boundary of Section 3, Block II, Whareorino Survey District; thence by the northern and north-western boundaries of Sections 4 and 3, Block I, Maungamangero Survey District, to the intersection of the Mangakokopu Road, across the said road, and thence easterly by the northern boundary of Sections 7 and 2 of Block I, Maungamangero Survey District, and Sections 5, 2, and 1 of Block II, Maungamangero Survey District, to the intersection of the Mahoenui-Kawhia Road; thence across the said road to the middle of the Mangaohao River; thence from this point to the intersection of the northern boundary of Section 7, Block I, Orahiru Survey District, with Section 1, Block IV, Kawhia South Survey District, as described in the First Schedule to the Waitomo County Act, 1904; thence eastwards along the northern boundary of the said Section 7 to the Hauturu Road; thence southwards along the middle of the said road to a point opposite to the northern boundary of Section 3, Block I, Orahiru Survey District; thence across that road and along the said boundary of Section 3 to the intersection with the Orongo Road; thence across the said road and along the southern side of the road to its intersection with the western boundary of Section 4, Block I, Orahiru Survey District; thence due south along the said eastern boundary of Section 4; south-easterly by the north-eastern boundary of Section 4 and the north-eastern boundary of Section 1, Block V, Orahiru Survey District; and eastwards generally by the north-east and eastern boundaries of the Hauturu East B No. 2 Block to where the northern boundary of Section 19, Block VII, Orahiru Survey District, intersects; thence eastward along the northern boundary of the said Section 19 and Section 18; thence north and eastwards again by the western and northern boundaries of the Hauturu East C No. 2B Block to the intersection of the Haurua Road, across the said road, and easterly and southwards along the northern and eastern boundaries of Section 7A and the eastern boundary of Section 8A, Block VIII, Orahiru Survey District, Hauturu East No. 2A 3, to the intersection of the Te Kuiti-Otorohanga Road, across the said road, and along the eastern and southern boundaries of Hauturu East No. 2 No. 2 Block to the intersection of the Te Kuiti-Otorohanga Road; thence south-easterly along the eastern boundary of Pukeroa-Hangatiki No. 1A Block to the Main Trunk Railway Reserve; thence along the western boundary of the railway reserve to the Waitomo Road, across the said road, across the Main Trunk Railway Reserve to the middle of the Whangamata Road, and northerly along the middle of the road to a point opposite to where the south-western boundary of the Pukeroa-Hangatiki No. 4D No. 2D No. 5A Block intersects the road; thence across the road and south-easterly along the south-western boundary of the said Pukeroa-Hangatiki No. 4D No. 2D No. 5A Block to the intersection of the Mangarapa Stream; thence southwards along the Mangarapa Stream to its intersection with the northern

boundary of Section 1, Block III, Orahiri Survey District; thence eastwards and southwards by the northern and eastern boundaries of the said Section 1 and the eastern boundary of Section 2, Block XII, Orahiri Survey District; thence southwards by the eastern boundary of Section 1, Block XVI, Orahiri Survey District, and Mangarapa No. 1B Block to a point where the eastern boundary of the Mangarapa No. 1B Block intersects the northern boundary of the said Section 1; thence eastwards by the northern boundaries of the said Section 1 and of the Te Kuiti No. 2B 14B Block; thence southwards along the eastern boundaries of the Te Kuiti No. 2B 14B, No. 2B 9B, and No. 2B 22 Blocks to a point where the northern boundary of the Rangitoto-Tuhua No. 71B Block intersects the eastern boundary of the said Te Kuiti No. 2B 22 Block; thence eastwards along the said northern boundary of the Rangitoto-Tuhua No. 71B Block and along the northern boundary of Rangitoto-Tuhua No. 69D Block to its intersection with the Otewa Road; thence across the said road and along the northern boundary of the Rangitoto-Tuhua No. 69B Block again; thence south-westerly by a right line to the south-western corner of Rangitoto-Tuhua No. 26B Block; thence easterly and northerly by the southern and eastern boundaries of the Rangitoto-Tuhua No. 26B Block to a point where the northern boundary of the Rangitoto-Tuhua No. 35B Block intersects the said eastern boundary of the Rangitoto-Tuhua No. 26B Block; thence generally easterly by the northern boundaries of the Rangitoto-Tuhua No. 35B Block to its intersection with Section 3, Block XIV, Mangarongo Survey District; thence easterly generally by the northern boundary of the said Section 3, across a road, and again by the northern boundary of the said Section 3, across a road, and easterly by the northern boundary of Section 4, Block XIV, Mangarongo Survey District; thence southerly along the eastern boundaries of the said Section 4 to the northern boundary of the Rangitoto-Tuhua No. 35B Block; thence south-easterly along the said boundary to the eastern boundary; thence southerly along the said boundary to its intersection with the Waipa River; thence along the middle of the Waipa River to a point where the northern boundary of the Rangitoto A No. 48A Block intersects; thence along the said northern boundary of the Rangitoto A No. 48B Block to the intersection of the Owawenga Stream; thence southwards along the Owawenga Stream to the point where the said stream intersects the eastern boundary of the Rangitoto A No. 50B Block; thence southwards along the eastern boundary of the Rangitoto A No. 50B Block; thence eastwards and southwards along the northern and eastern boundaries of the Rangitoto A No. 67A Block; thence easterly along the northern boundary of the Rangitoto A No. 60 Block, southern portion; thence northwards along the eastern boundary of the Rangitoto A No. 49B Block to the intersection of the southern boundary of the Rangitoto A No. 30B Block; thence eastwards along the said southern boundary of Rangitoto A No. 30B Block; thence south-easterly along the south-western boundaries of the Rangitoto A Nos. 28 and 40 Blocks; thence eastwards along the southern boundary of the Rangitoto A No. 40 Block; thence in a south-easterly direction along the south-western boundary of the Rangitoto A No. 29A Block and the Rangitoto B Block; thence westerly along the southern boundaries of the Rangitoto A No. 31B Block to its intersection with a right line drawn from the Rangitoto Trig. to the source of the Ongarue River; thence southerly along the said right line to the Ongarue River; thence in a westerly direction along the middle of the said Ongarue River to the Ohura County; thence westerly generally along the northern boundary of the said Ohura County to the Clifton County; thence westerly generally by the northern boundary of the Clifton County to the sea; thence towards the west by the sea to the place of commencement: excluding the Borough of Te Kuiti.

FOURTH SCHEDULE.

KAWHIA COUNTY.

ALL that area of land in the Auckland Land District bounded by a line commencing where the south boundary of Raglan County (as described in the Fifth Schedule to this Act) meets the Aotea Harbour; thence easterly by the southern boundary of Raglan County; thence southerly by the western boundary of Otorohanga and Waitomo Counties (as described in the First and Third Schedules respectively to this Act); thence westerly by the northern boundary of Waitomo County to the sea; thence northerly by the sea to Kawhia Harbour; thence by the confines of that harbour to the sea; thence by the sea to the Aotea Harbour; thence by the south-east boundary of that harbour to the point of commencement.

FIFTH SCHEDULE.

RAGLAN COUNTY.

ALL that area of land in the Auckland Land District bounded by a line commencing at the mouth of the Waikato River, and proceeding thence up the left bank of that river to its confluence with the Whangamarino Stream; thence up the middle of the Waikato River, but so as to exclude all islands, to a point opposite to the south boundary of Lot 36, Parish of Waipa; thence along the south boundary of that lot and a projection thereof to its intersection with the eastern boundary of Lot 27, Parish of Waipa; thence southerly along the eastern boundary of that lot to the southern boundary of Lot 40B, Parish of Waipa; thence along the southern boundary of that lot and a projection thereof to the middle of the Waipa River; thence along the middle of that river in a southerly direction to its junction with the Mangauika Stream; thence along that stream to its intersection on the southern boundary of Lot 329, Parish of Pirongia; thence along the southern boundaries of Lots 329, 306, and 365, all of the Parish of Pirongia, to the intersection of the eastern boundary of Section 2, Block III, Pirongia Survey District; thence along the eastern boundaries of Sections 2 and 4; thence westerly along the southern boundaries of Sections 4 and 1, all of Block III, Pirongia Survey District, to the intersection of the eastern boundary of Section 5, Block VII, Pirongia Survey District; thence along the eastern boundary of that section to its southern boundary; thence along the southern boundaries of Sections 6 and 4, Block VII, Pirongia Survey District; thence northerly along the western boundaries of the said Section 4 and Native reserve to the southern boundary of education reserve; thence along the south-western boundary of the said education reserve to its north-western boundary; thence along that boundary and the north-western boundary of the Mangauika B No. 2 Section 2 Block to Trig. 1922; thence along the south-western boundaries of Lot 358, across a road, and along the south-western boundary of Lot 352, both of Parish of Pirongia, to the intersection of the south-eastern boundary of the proposed water-catchment area; thence south-westerly along the southern boundary of that area to its intersection with the eastern boundary of Section 5, Block I, Pirongia Survey District; thence along the eastern and northern boundaries of that section to its intersection with the Otungaoko Road, across that road, and following that road to the southern boundary of Section 7; thence along the southern boundaries of the said Section 7 and Section 4, all of Block IV, Kawhia North Survey District, to a road; thence northerly along the eastern boundary of that road to a point opposite to the southern boundary of Section 8, Block XV, Karioi Survey District; thence across that road and along the southern boundaries of the said Section 8, and of Section 7, Block XV, Karioi Survey District, and of Section 18, Block XIV, Karioi Survey District, across a road, and generally along the southern boundaries of Sections 19 and 16, Block XIV, Karioi Survey District, to the intersection with the eastern boundary of the Moerangi No. 3B Block; thence northerly along the said eastern boundary to the intersection of a road; thence south-westerly along that road to the Aotea Harbour; along the southern boundaries generally of that harbour to the sea; thence along the sea to the point of commencement.

SIXTH SCHEDULE.

WAIKATO COUNTY.

ALL that area of land in the Auckland Land District bounded by a line commencing at the confluence of the Whangamarino River with the Waikato River, and proceeding thence up the middle of the said Whangamarino River, up the middle of the Maramarua River, and up the middle of the Mangatangi Stream to its intersection with the Mercer-Pukorokoro Road; thence easterly along the middle of that road to Allotment 82, Parish of Koheroa, and along the western and northern boundary of that allotment to the Firth of Thames, at the mouth of Pukorokoro Creek; thence southerly generally along the confiscation boundary to the most north-westerly point of the Karokaro A Block; thence easterly along the southern boundary of the Piako County (hereinbefore described) to the most south-westerly point of the Tawawahakapuoro Block; thence westerly along the southern boundary of the Tawawahakapuoro Block to the intersection of the south-eastern boundary of the Maungakawa Block; thence south-west along the south-western boundary of the said Maungakawa Block to the intersection of Section 6s, Te Miro Settlement; thence along the south-eastern boundaries of

Sections 6s, 5s, and 3s, Te Miro Settlement, and south-eastern boundary of the sanatorium reserve in Block VI, Cambridge Survey District, to the intersection with the confiscation boundary; thence southwards along the confiscation boundary to the Opuahau Trig.; thence south-westerly along the south-east boundary of Lot 8, Hautapu Parish, to the intersection of the Karapiro Stream; thence westward along the said Karapiro Stream to the western boundary of the Borough of Cambridge; thence northerly, westerly, and southerly along the said Borough of Cambridge boundary to the middle of the Waikato River; thence along the middle of that river to a point opposite to the eastern boundary of the Borough of Hamilton; thence northwards along the eastern boundary of the aforesaid borough and westward along northern boundary of the aforesaid borough to the middle of the Waikato River; thence northwards along the middle of that river to a point opposite to the south-eastern boundary of the Borough of Nguruawahia; thence following the south-eastern, north-eastern, and northern boundaries of that borough and a production of the said northern boundary to the middle of the Waikato River; thence northwards along the middle of that river to a point opposite to the southern boundary of the Town District of Huntly; thence to and along the southern, eastern, and northern boundaries of the said town district, and a production of the said northern boundary to the middle of the Waikato River; thence northwards generally along the middle of that river, so as to include within the said boundaries all islands in the said river, to the Whangamarino River to the place of commencement.

SEVENTH SCHEDULE.

PIAKO COUNTY.

ALL that area in the Auckland Land District bounded by a line commencing at the intersection of Hoa-o-Tainui South No. 4A Block at its south-western corner with the old confiscation boundary-line; thence easterly along south boundaries of Hoe-o-Tainui South No. 4A Block, Sections 2, 3, and 7, Block IX, Hapuakohe Survey District, and Willis's Grant, and a production of the latter boundary to the middle of the Piako River; thence northerly along the middle of that river to a point opposite a road at the south-western corner of Section 5, Block I, Waitoa Survey District (creamery reserve); thence to and following the northern side of the said road in a north-easterly direction to the Waitoa River; thence across that river to a road running north-easterly, and following that road to its junction with road in Otway's Settlement at the north-western corner of the apiary reserve; thence in a north-easterly direction by a road to the Waihou River; thence southerly by the left bank of that river to the Te Aroha Borough boundary; thence generally southerly, easterly, and northerly along the boundary of the said borough to the intersection of the line between Survey Blocks IX and X, Aroha Survey District, with the old county boundary-line; thence easterly by the said old county boundary-line to Trig. 567, Te Aroha; thence north-easterly by the confiscation boundary-line to the old county boundary-line between Piako and Tauranga Counties, as set forth in the boundaries of Piako County, New Zealand Statutes of 1876, page 185; thence south-easterly by the western boundary of a forest reserve in Katikati and Aongatete Survey Districts to its intersection on Whakamarama No. 2 Block; thence south-westerly by the northern boundaries of Okauia No. 1 Block; thence by the Wairere Stream and Waihou River to a point opposite the production of the north-western boundary-line of Section 27A, Block X, Wairere Survey District, to the Waihou River; thence south-westerly along that produced boundary and the north-western boundaries of Sections 27A and 27, Block X, Wairere Survey District, and Lot 24A of Turanga-o-Moana Block; thence north and west generally along the southern boundaries of Turanga-o-Moana, Aratiatia, Taramorahi No. 1, and Matamata North Blocks to the middle of the Waitoa River; thence along the middle of that river to its confluence with the Mangapapa River; thence generally southerly by the said Mangapapa River to the south-eastern corner of Te Pae-o-tu-Rawaru Block; thence by the southern boundary of the aforesaid block to its intersection with the Tawawahakapuoro Block; thence generally northerly by the eastern boundaries of Tawawahakapuoro, Te Konehu, Kiwitahi Nos. 1F, 1E, and 1D Blocks; thence by the northern and western boundaries of the Kiwitahi No. 1D Block to the north-eastern corner of Kiwitahi No. 2 Block; thence by the northern boundaries of the Kiwitahi Nos. 2 and 3A and Karokaro Blocks to the confiscation boundary-line; thence north-westerly along that line to the point of commencement: excluding the Borough of Morrinsville.

EIGHTH SCHEDULE.

- WAIPA COUNTY.

ALL that area in the Auckland Land District bounded by a line commencing at the centre of the Waikato River at a point where a production of the southern boundary of the Borough of Ngaruawahia intersects the centre of the said river; thence following the middle of the Waikato River to a point opposite to the north-western boundary of the Borough of Hamilton; thence by the western and southern boundaries of the aforesaid borough to the middle of the Waikato River; thence by the middle of the aforesaid river to a point opposite to the north-eastern corner of Lot 227, Pukekura Parish; thence by the eastern boundary of Lot 227 and a production thereof across a road, by the eastern boundary of Lot 185, across a road, by the eastern boundaries of Lots 185 and 186, across a road, by the eastern boundary of Lot 187, across a road, and by the eastern boundary of Lot 226, being all lots of Pukekura Parish, to Trig. 52, Pukekura; thence south-easterly by the north-east boundaries of the Pukekura Nos. 18B 1c, 18B 1B, 18B 1A, and 18B 2 Blocks; thence south-westerly by the south-east boundary of the aforesaid Pukekura 18B 2 Block; thence south-easterly by the north-east boundary of the Pukekura Nos. 17 and 15 Blocks; thence towards the south-east by a right line from the eastern corner of Pukekura No. 15 Block to Trig. 1427, Maungatautari; thence south-easterly by a right line from the aforesaid Trig. 1427 to the middle of the Waikato River at a point opposite to the north-western corner of Section 9, Block XII, Maungatautari Survey District; thence generally southerly by the middle of that river to a point opposite to the south-eastern corner of Section 3, Block III, Wharepapa Survey District; thence by county boundaries of Otorohanga and Raglan Counties (as described in the First and Fifth Schedules respectively to this Act) to a point in the middle of the Waipa River opposite to the southern boundary of the Borough of Ngaruawahia; thence by the said southern boundary of the Borough of Ngaruawahia and a production thereof to the place of commencement excluding the Borough of Te Awamutu.

NINTH SCHEDULE.

TAUPO COUNTY.

ALL that area in the Auckland, Hawke's Bay, and Wellington Land Districts bounded by a line commencing at a point on the north-western shore of Lake Taupo, being the southernmost corner of Tihoi No. 1 Block, and proceeding thence along the north-western boundaries of Tihoi Nos. 1 and 3 Blocks to Pureora; thence to the source of the Ongarue Stream, and along the north-western boundary of the Waitomo County (hereinbefore described) to the south-eastern boundary of the Otorohanga County (hereinbefore described), and along that boundary to the Waikato River; thence up the middle of that river to a point in line between the mouth of the Waihora Stream in Lake Taupo and Trig. Station 807 (Araura); thence along a right line to Trig. Station 807 (Oraura), along a right line to Trig. Station 31 (Paeroa), and a right line to Trig. Station 76A (Tawhiwau); thence along a right line running in the direction of Trig. Station 69 (Tatarakino) to its intersection by a right line from a point where the Napier-Taupo Road crosses the Rangitaikei River to the most northerly point of Lake Waikaremoana; thence along a right line to a point on the Te Hoe River at the south-eastern corner of Heruiwi No. 4 Block, and along the middle of that river to and along the middle of the Mohaka River to its intersection by the production of a right line running from Trig. Station 65A (Kaweka Range) to 68A; thence along the said right line to Trig. Station 65A, a right line thence to Trig. Station 26 (Tawhaketewhango), a right line to Trig. Station 27; thence along a right line to Trig. Station 28 (Manukaiapu), a right line to Ruapehu Trig. Station, a right line to Trig. Station H (Paretaitonga), a right line hence to Trig. Station D (Ngauruhoe), a right line to Tongariro Trig. Station; and thence along a right line to the western shore of Lake Taupo at the mouth of the Waihi Stream, and along the western shore of Lake Taupo to the place of commencement.

TENTH SCHEDULE.

TAUPO ROAD DISTRICT.

ALL that area of land in the Auckland Land District commencing at the mouth of the Utumuheke Stream; thence generally easterly by that stream to the north-west boundary of Section 4; thence north-easterly by the north-western boundary of Section 4 to the northern boundary of the said section; thence easterly by the northern boundary of the said section to its eastern boundary; thence southerly by the eastern boundary of the said section to its southern boundary; thence south-westerly by the eastern boundary of Section 20 to the Rotokawa Road; thence across the said road by a continuation of the eastern boundary of the said Section 20; thence generally easterly by the said Rotokawa Road to the north-eastern corner of Section 23; thence south-westerly by the eastern boundary of Section 23 to Paetiki Road; thence across the said road by a continuation of the eastern boundary of Section 23; thence generally easterly by the Paetiki Road to the north-eastern corner of Section 22; thence southerly by the eastern boundary of Section 22 to the Taupo-Napier Road; thence generally westerly by the said road to the eastern boundary of Section 7; thence south-westerly by the eastern boundary of Section 7 to a road on the south-eastern corner; thence generally westerly by that road to its junction with the Taupo-Tokaanu Road; thence due west by an imaginary line to shores of Lake Taupo; thence by the shores of the said Lake Taupo to the mouth of the Waikato River; thence by the Waikato River to the point of commencement: all in Block II, Tauhara Survey District.
