#### A BILL INTITULED

An Act to amend the Christchurch Tramway District Act 1920

- BE IT ENACTED by the General Assembly of New Zealand 5 in Parliament assembled, and by authority of the same, as follows:
- 1. Short Title—This Act may be cited as the Christchurch Tramway District Amendment Act 1970, and shall be read together with and deemed part of the Christchurch Tramway 10 District Act 1920 (hereinafter referred to as the principal Act).
  - 2. Salary of Chairman—Section 25 of the principal Act is hereby amended by omitting the words "two hundred pounds", and substituting the expression "\$800".

3. Members' fees—The principal Act is hereby amended by repealing section 26, and substituting the following section:

"26. The Board may from time to time vote and pay to each member of the Board, exclusive of the Chairman, a fee or sum not exceeding \$156 during any year of office, and for this purpose each year shall be deemed to commence on the last Tuesday in November:

"Provided that the amount payable to each member shall be reduced by the sum of \$3 in respect of each meeting of the 10 Board or a committee of the whole of the Board at which he is not present at the time appointed for the holding of such

meeting or within 15 minutes thereafter:

"Provided further than not more than \$3 shall be deducted in respect of any member when 2 or more meetings are held 15 on the same day."

4. Unauthorised expenditure—Section 11 of the Christchurch Tramway District Amendment Act 1921 is hereby amended by omitting the words "two hundred and fifty pounds", and substituting the expression "\$1,000".

3A. Members' fees—Section 26 of the principal Act is hereby amended—

(a) By omitting the words "one pound ten shillings", and

substituting the expression "\$5":

(b) By omitting from the third proviso the words "seventy-eight pounds", and substituting the expression "\$260":

(c) By omitting from the third proviso (as amended by section 2 (2) (c) of the Local Elections and Polls 30 Amendment Act 1960) the words "first Saturday in October", and substituting the words "second Saturday in October".

#### New

4. Unauthorised expenditure—(1) The principal Act is 35 hereby amended by inserting, after section 66, the following section:

"66A. The Board may in any financial year expend for purposes not authorised by any Act or law for the time being in force any sum or sums not amounting in the aggregate to 40 more than \$1,000."

(2) Section 11 of the Christchurch Tramway District Amendment Act 1921 is hereby repealed.
