A BILL INTITULED

AN ACT to amend the Defence Act, 1909.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows :-

1. This Act may be cited as the Defence Amendment Act, Short Title. 1910, and shall form part of and be read together with the Defence Act, 1909 (hereinafter called the principal Act.)

2. Section five of the principal Act is hereby amended by Section 5 of 10 omitting all the words of paragraph (b) after the word "responsible," principal Act amended. and substituting the words "for the organization, discipline, training, and efficiency of the Forces; and may also appoint such staff as may be necessary to assist the Commandant."

3. Section twelve of the principal Act is hereby repealed, and Repeal: Commandant 15 all references in that Act to the Council of Defence shall hereafter, substituted for except as specially provided by this Act be deemed to be references Council of Defence. to the Commandant, or, if there is no Commandant, then to the officer appointed to act for him.

New.

4. (1.) Regulations made under the principal Act may declare Exempted 20 what classes of persons shall be exempt from liability to be transferred from the General Training Section to the Territorial Force as provided by section twenty-three of the principal Act.

(2.) The burden of proving exemption from such liability shall 25 rest on the person claiming exemption.

4. (3.) Section twenty-three of the principal Act is hereby amended Section 23 of by omitting the words "either by ballot or " in subsection two.

5. Subsection three of section twenty-five of the principal Act is hereby repealed, and the following substituted in lieu thereof :---

"(3.) Every member of the Territorial Force shall, on attaining the age of twenty-five years, be drafted in the prescribed manner into the Reserve:

"Provided that on application any officer, warrant officer, or sergeant may, if approved, be permitted to continue in the Territorial **5** Force, but not beyond the age for retirement prescribed for the rank for the time being held by him."

6. (1.) Section thirty-five of the principal Act is hereby amended by omitting paragraphs (c) and (d), and substituting the following :—

- "(c.) From eighteen years of age, or from any later date no 10 which they cease to attend a secondary school as aforesaid, to twenty-five years of age, in the General Training Section, or the Territorial Force in the case of their transfer to that Force; and
- "(d.) From twenty-five years to thirty years of age, in the 15 Reserve."

New.

(2.) Nothing in this section shall affect any person who on the commencement of this Act is over the age of twenty-one years, but every such person who is over that age and is not over thirty years 20 of age shall continue to be liable to be trained as if this Act had not been passed.

Scout Cadets.

7. (1.) The Minister of Education may, at the request of the controlling authority, take over the control of the Boy Scouts or any 25 of them who are not Junior Cadets, and when so taken over they shall form a separate branch of the Junior Cadets and be known as the "Scout Cadets," and be subject to the provisions of the principal Act so far as they relate to the Junior Cadets, except that the restrictions as to age-limit contained in subsection one of section 30 thirty-seven thereof shall not apply to Scout Cadets, and Scout Cadets may continue as such until they attain the age of eighteen years or cease to attend a secondary school, whichever is the later.

(2.) The amount of training of the Scout Cadets shall be equivalent to that fixed for the Senior Cadets, and shall be as **35** prescribed by regulations.

7. (1.) The Minister of Defence and the Minister of Education may at the request of the controlling authority take over the control of the Boy Scouts, or permit the formation of Boy Scout units in the 40 Senior and Junior Cadets respectively.

(1A.) Such units may be designated Boy Scout Cadets, and wear the Scout uniform, but shall be subject to the provisions of the principal Act so far as they relate to Senior and Junior Cadets.

(2.) The training of the Boy Scout Cadets shall be as prescribed 45 for Senior and Junior Cadets, and in addition they may practise the training set out in the Scout-training text-book.

(3.) All Scout Cadets, on attaining the age of eighteen years, or on any later date on which they cease to attend a secondary school, shall be drafted in the manner prescribed into the General 50 Training Section.

(4.) This section is in substitution for section thirty-nine of the Repeal. principal Act; and that section is hereby accordingly repealed.

8. Section forty of the principal Act is hereby amended by Section 40 of repealing subsection two, and substituting the following :---

"(2.) The compulsory training in the Senior Cadets in any year ending on the last day of February shall not exceed be less than sixty-four hours."

9. Section forty-one of the principal Act is hereby amended as Section 41 of follows :---

(a.) As to subsection one, by inserting, after the words "Senior Cadets," the words "or Scout Cadets";

10. (1.) When, except in time of war, any officer or non-commissioned officer is dismissed he shall have a right of appeal to a 30 Board of Appeal as hereinafter mentioned.

(2.) The Board shall consist of-

The Chief Justice, or some other Judge of the Supreme Court appointed by the Chief Justice, who shall be President of the Board; and

Two officers of a rank not lower than that of Colonel.

(3.) The Board in the case of every appeal shall be deemed to be a Commission within the meaning of section thirteen of the Commissions of Inquiry Act, 1908.

(4.) The Governor may from time to time, by Order in Council gazetted, make regulations prescribing the procedure for bringing an 40 appeal before the Board.

(5.) This section shall extend and apply to all dismissals made during the twelve months preceding the passing of this Act, as well as to subsequent dismissals.

11. Section fifty-nine of the Defence Act, 1908, is hereby Capitation 45 amended by repealing subsection two, and substituting the followallowance. ing:-

"(2.) The capitation allowance in respect of each member shall be paid to the officer commanding the corps to which the member 50 belongs, and shall be held by that officer as the property of the corps and applied in defraying such incidental expenses of the corps as are authorised by regulations."

12. (1.) The officer commanding each corps shall cause accounts to be kept of the income and expenditure and the assets and liabilities of the corps, and shall during the month of April in each year cause such accounts to be balanced to the thirty-first day of March of that vear.

(2.) All such accounts shall from time to time be audited by the Audit Office.

12A. (1.) The Governor may, from time to time, by warrant under his hand— 10

- (a.) Convene or authorise any qualified officer to convene a general Court-martial for the trial, under this Act, of any person subject to military law; and
- (b.) Give a general authority to any qualified officer to convene general or district Courts-martial for the trial, under this 15 Act, of such persons subject to military law as are for the time being under or within the territorial limits of his command; and
- (c.) Empower any qualified officer to delegate to any officer under his command, not below the degree of field-officer 20 of the Permanent Force or Permanent Staff, a general authority to convene general or district Courts-martial for the trial, under this Act, of such persons subject to military law, as are for the time being under or within the territorial limits of his command; and
- (d.) Reserve for confirmation by himself, or empower any qualified officer to confirm, the findings and sentences of general or district Courts-martial; and
- (e.) Empower any officer for the time being authorised to confirm the findings and sentences of general or district Courts- 30 martial to reserve for confirmation such findings and sentences; and.
- (*f*.) Make regulations for the convening, composition, procedure, and powers of Courts-martial.

(2.) For the purposes of this section "qualified officer" means 35 the Commandant of the Defence Forces; the Officer Commanding the Permanent Force; an Officer Commanding a District.

(3.) For the purposes of this section the following persons are persons subject to military law as officers :---

(a.) Officers of the Permanent Force and Permanent Staff; and 40

(b.) All other officers of the Defence Forces on all occasions when performing military duty, or going to or from the

place of parade, exercise, or military duty.

(4.) For the purposes of this section the following persons are persons subject to military law as soldiers: Non-commissioned 45 officers and men of the Defence Forces (including the Permanent Staff), on all occasions when performing military duty, or going to or from the place of parade, exercise, or military duty.

(5.) The powers and duties of Courts-martial shall be as prescribed by regulations made hereunder.

(6.) The provisions of the Army Act in so far as they relate to Courts-martial shall, subject to the provisions of this Act, apply to Courts-martial convened under this Act.

(6A.) All military inquiries shall be open to the Press, except when the Court is dealing with matters of procedure, or is deliberating.

5 (7.) The rules of evidence and the rules of procedure contained in the Manual of Military Law published by the British War Office shall, *mutatis mutandis*, apply to all proceedings of Courts-martial.

(7A.) This section shall extend and apply to all dismissals made during the twelve months preceding the passing of this Act:

10 Provided that the right to a trial by Court-martial be claimed by the person dismissed within *three* months after the passing of this Act.

(8.) This section is in substitution for section seventy-two of the Defence Act, 1909, and that section is hereby repealed accordingly.

12B. All regulations made under this Act or the principal Act Regulations be laid before Parliament within fourteen days after the gazet- ^{to be laid before} Parliament. 15shall be laid before Parliament within fourteen days after the gazetting thereof if Parliament is then sitting, or, if not, then within fourteen days after the commencement of the next ensuing session.

13. The principal Act is hereby further amended in the manner consequential 20 and to the extent indicated in the Schedule hereto. amendments.
