A BILL INTITULED

An Act to Amend the Emergency Regulations Act, 1939. Title. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority 5 of the same, as follows:—

1. This Act may be cited as the Emergency Short Title. Regulations Amendment Act, 1949, and shall be read together with and deemed part of the Emergency Regu- 1939, No. 8 lations Act, 1939 (hereinafter referred to as the principal ·10 Act).

(3) The Second Schedule to the Emergency Regulations Continuance Act, 1947, is hereby amended by repealing so much thereof as relates to the regulations hereby revoked.

The Second Schedule to the Emergency Regulations Continuance Act, 1947 (as amended by the last preceding section and by section seven of the Industrial Relations Act, 1949) is hereby further amended by repealing so much thereof as relates to the regulations specified in the Second Schedule to this Act (being 10 regulations that have been revoked by other enactments).

4. The emergency regulations specified in the Third Schedule to this Act, unless they are sooner revoked by the Governor-General in Council or by any Act, shall continue in force until the thirty-first day of December, 15 nineteen hundred and fifty, and shall then expire.
