A BILL INTITULED

AN ACT to constitute a Harbour Board for the Harbour of Greymouth. Title. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as fol-5 lows :---

1. The Short Title of this Act is "The Greymouth Harbour short Title. Board Act, 1884."

It shall be deemed to be a special Act within the meaning of "The Harbours Act, 1878."

10 2. In this Act,-

> "Board" means the Harbour Board constituted under this Act:

> "Harbour of Greymouth" and "Harbour" means the Port of Greymouth, as defined by a warrant dated the twentieth day of November, one thousand eight hundred and sixty-

eight, and issued under "The Marine Act, 1867."

"The said Act" means "The Harbours Act, 1878."

3. A Harbour Board is hereby constituted under the said Act for the Harbour of Greymouth, and such Board shall consist of the 20 members following, seven members to be appointed by the Governor in Council, of whom four shall form a quorum; that is to say,-

(4.) One member to be elected jointly by all persons who, at the time of the election of members of the Board, or within twenty-eight days preceding, are registered owners of vessels in the harbour of Greymouth of a registered tonnage or aggregate registered tonnage of fifty tons or upwards; and by all persons who shall have paid five pounds or upwards of harbour, pilotage, or wharfage dues within the said harbour during the year preceding the election of members of the Board.

4. The members of the Board, to be appointed by the Governor, 10 may be appointed at any time after the passing of this Act, and they shall hold office from the date of such appointment to the first day of July, one thousand eight hundred and eighty-five, seven, and thereafter for the period of two years, prescribed by the said Act: Provided that the Governor may from time to time remove any member so 15 appointed and appoint another person in his place.

5. The first election of the elective members shall be held on the second Monday in the month of February, in the year one thousand eight hundred and eighty-five.

6. The elective members of the Board shall come into office on 20their election, and shall hold office from the time of their election until the biennial election of members of the Board, to be held in February, in the year one thousand eight hundred and eighty-seven.

7. The Collector of Customs at Greymouth shall, in the month of January in each year, furnish to the Secretary of the Board a list 25of all persons being registered owners of vessels of a registered tonnage or aggregate registered tonnage of fifty tons or upwards.

The Secretary of the Board shall, in the month of January next, prepare a list of all those who shall have in the twelve preceding months paid the sum of five pounds and above that sum for harbour or jetty dues, and the said Secretary shall thereafter, in the month of January in each year, prepare such a list.

8. The list aforesaid, when prepared, shall be the voters' list for the year for the election of persons to serve as members by the owners of vessels and the payers of dues; and such election shall be 35 conducted in conformity with the provisions of "The Regulation of Local Elections Act, 1876."

9. For the purpose of the immediate operation of this Act, the Governor shall appoint the four nominated members as aforesaid, and shall at the same time appoint three additional persons to be members! 40 of the Board for the complete formation thereof pending the election of the elective members.

The additional members so appointed by the Governor shall cease to hold office on the coming into office of the elected members of the Board under this Act.

Members to be paid their expenses.

10. 5. Every member of the Board shall be entitled to be paid out of the revenues of the Board his actual expenses out of pocket in respect of his attendance at the meetings of the Board.

6. The Board may from time to time appoint some fit person Appointment of to be Engineer of works, but every such appointment shall be subject Engineer of works. 5 to the approval of the Governor.

11. 7. The Board is hereby endowed with the revenues hereinafter Endowments of next mentioned, and all such revenues, as they accrue from time to Board. time, shall be paid by the persons receiving the same to the Board, that is to say,---

- (1.) All moneys arising from the lease, occupation, or other disposal, and the rents, royalties, fees, and other moneys derivable from the pieces of land known as the Westland-Grey Coal Reserve and the Nelson-Grey Coal Reserve, as the same are respectively described in the First and Second Schedules of "The Westland and Nelson Coal Fields Administration Act, 1877," less all costs and expenses of collecting the same.
 - (2.) All profits arising from the Greymouth-Brunner Coal Field Railway remaining after payment of all the cost of maintenance and working expenses, and any claims for compensation in respect of injuries arising from accidents on the railway; and
 - (3.) All wharfage and tonnage rates in the Harbour of Greymouth, including all charges for the use of staiths and other charges on coal brought for shipment in the said harbour, less all costs and expenses of collecting the same.

12.8. The Board shall have power, from time to time to borrow Borrowing powers. on the security of its endowments, subject to the provisions of the said Act, and to the Governor's previous approval of a plan of the 30 works proposed to be constructed, any sum not exceeding two one hun-

dred thousand pounds, for the construction or completion of harbour works in, or towards the improvement of, the said harbour.

But no money shall be borrowed under the authority of this Act Governor in Council at a higher rate of interest than six per centum per annum, anything may declare loan guaranteed. 35 contained in the said Act notwithstanding.

13.9. If the Governor in Council is satisfied at any time that the revenues accruing to the Board under this Act are sufficient to meet the interest on any loan proposed to be raised under the authority of this Act, and to provide a sinking fund for repayment thereof, he

40 may declare such loan and interest to be guaranteed under this Act; and from the date of the Order in Council declaring the guarantee, the interest on such loan shall be paid out of the Consolidated Fund.

But no greater sum than one hundred thousand pounds in the Limitation. whole shall be guaranteed under this Act except such extended 45 guarantee be sanctioned by a resolution passed in that behalf by each House of the General Assembly.

14. 10. Notwithstanding anything contained in the said Act, in the Form of debentures event of a guarantee being declared as aforesaid, the Governor, and in case of guarantee. any persons whom he may appoint as agents for the purpose, either

50 within or beyond the colony, may make and issue debentures under this Act and the said Act in such form as the Governor or such agents respectively may think fit.

All moneys advanced from the Consolidated Fund under the *last-preceding* section shall be charged against the revenues of the Board, and shall be repaid to the said fund by the Board, together with so much added, as will provide a sinking fund to liquidate the amount of the loan guaranteed under this Act.

Such sinking fund shall be of such amount and payable at such dates respectively, commencing not later than five years after the date when the guarantee aforesaid takes effect, as shall be agreed upon between the Governor and the Board.

16.12. The Board constituted under this Act may be dissolved at 10 any time in the event that the General Assembly shall pass an Act authorizing the Governor to take over the harbour works progressing at the said harbour, together with all contracts and engagements of the Board in relation thereto, as well as all other contracts and engagements of the Board, and its assets and liabilities, and to 15 complete the said works on behalf of Her Majesty the Queen.

New clause.

13. So much of "The Westland and Nelson Coal Fields Administration Act, 1877," as is repugnant to, or in conflict with, the provisions of this Act, is hereby repealed.
