A BILL INTITULED

AN ACT to constitute the Hokonui County.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Hokonui County Act, 1914.

Short Title.

2. (1.) The Hokonui County is hereby constituted, and shall comprise that portion of the Southland County particularly described in the *First* Schedule hereto.

Hokonui County constituted.

10 (2.) The boundaries of the Southland County as hereby altered are described in the *Second* Schedule hereto.

(3.) The Counties Act, 1908, shall be in operation over the whole of the Hokonui County.

15 3. From and after the coming into operation of this Act no local authority other than the Hokonui County Council shall within the limits of the Hokonui County exercise any jurisdiction or authority over any roads or over or in relation to any matter or thing in respect of which jurisdiction is conferred upon a County Council under any Act:

Jurisdiction of Hokonui County Council.

20 Provided that nothing herein shall affect the power of the Governor to proclaim any portion of the said county a borough or town district.

4. This Act shall come into operation on the first day of April, nineteen hundred and *fifteen*.

FIRST SCHEDULE.

HOKONUI COUNTY.

ALL that area situated in the Otago Provincial District and Otago and Southland Land Districts, bounded as follows: Commencing on the east bank of the Mataura River at its junction with the Mimihau Stream, and proceeding in a northerly

direction along the east bank of the Mataura River to the south boundary of the Mataura Borough; thence generally in a westerly direction by the western and southern boundaries of Mataura Borough, by the Main South Road, the southern boundary of Allotments 54, 53, 52, 50, 49, 48, 58, 62, Land Transfer Plan 134, Southland Registry, Lots 4 and 12, Land Transfer Plan 174 of said registry, Lots 41 and 40, Plan 175A of said registry, and Part of Lot 39, Plan 175A of said registry, to a point formed by the production of the south boundary of Lot 25, Plan 176A of said registry; thence by a line forming the production of the said boundary and by the south boundary of Lots 25 and 24, Land Transfer Plan 176A, Lindhurst Hundred, to the south-western corner of said Lot 24, Plan 176A; thence towards the west by the western boundary of Lot 24, northern boundary of Lot 23, and its production to the western boundary of Block II, Lindhurst Hundred; thence by the western boundary of said Block II, Lindhurst Hundred, to its junction with the southern boundary of the Waimumu Hundred; thence by the southern boundary of the said Waimumu Hundred to the south-western corner of the said Hundred; thence due north by the western boundary of said Hundred to its junction with the southern boundary of Hokonui District; thence due west by the southern boundary of Hokonui District to the south-west corner of Section 253 of that district; thence due north by western boundary of Sections 253 and 267, Hokonui District, to north-west corner of Section 267; thence due east by northern boundary of Section 267 to the Otamita Stream; thence northerly and westerly by the Otamita Stream to the north-eastern corner of Section 798, Hokonui District; thence by the Otamita Stream and north-eastern boundary of said Section 798 to the western corner of Section 361; thence by a road-line forming the north-western boundary of Section 361, Crown lands, and Section 291, Hokonui, and by part of Section 179, Hokonui District, to the south-western boundary of that section; thence by the south-western boundary of Sections 179, 91, 108, 894, 92, 121, 93, 28, 109, 110, 94, 27, 111, 95, 26, and 96, Hokonui District; thence by the north-western boundary of Section 96 and that boundary produced to western boundary of Section 24, Hokonui District; thence by the south-western boundary of Section 24 and by its production across road-line and by the south-western boundary of Section 221, Hokonui District, to the east bank of Oreti River; thence generally towards the west and north by the Wallace County to its junction with the Lake County at Hummock Peak; thence towards the north by the Lake County to its junction with the Vincent County at Lorn Peak; thence by the Vincent County to a point in the Umbrella Mountains due east of Rocky Mount; thence towards the east by the Tuapeka and Clutha Counties to the south-eastern corner of Section 2, Block VI, Slopedown District; thence by the south-eastern boundary of said section and south-western boundary of Section 3, Block VI, to the road-line forming the southern boundary of Section 15, Block II, Slopedown District; thence by the said road-line to the north branch of the Mimihau Stream; thence by the said north branch of the Mimihau Stream and the Mimihau Stream to the commencing-point: excepting, nevertheless, out of the said area the Boroughs of Gore and Mataura.

## SECOND SCHEDULE.

### SOUTHLAND COUNTY.

ALL that area in the Southland Land District bounded as follows: Commencing at a point on the Taringatura Hills, and bounded thence towards the north by the Wallace County to the Oreti River; thence towards the north-east by the Hokonui County to its junction with the Clutha County; thence towards the east by the Clutha County to the ocean; thence towards the south by the ocean to the mouth of the Waimatuku Stream; thence towards the west by the Wallace County to the commencing-point.
