A BILL INTITULED

An Act to empower the Hamilton City Council more effectively to deal with the park called Parana Park

- WHEREAS George Parr, of Hamilton, farmer, deceased, who
5 died on or about the twenty-sixth day of February, nineteen
hundred and twenty-nine, did by his last will, probate whereof
was granted to the Public Trustee, give and devise his freehold
property being Number 3 River Road, Hamilton, and being
part Allotment 219 of the Parish of Kirikiriroa: As the same
10 is more particularly delineated on a plan deposited in the
Land Registry Office at Auckland under Number S 3401 and
thereon subdivided into Lots 1, 2, and 3 (hereinafter called
Parana Park) unto the Mayor, Councillors, and Burgesses of
the Borough of Hamilton to be used as follows:
- 15 (a) As to the dwellinghouse situated thereon, together with
such amount of land as the Hamilton Borough
Council for the time being shall think necessary, for
a children's convalescent home for patients from the
Waikato Hospital:

(b) As to the remainder of the land comprised in the said freehold property for a children's playground, to be known as Parana Park:

And whereas the dwellinghouse mentioned in the said will is situated on Lot 1 on the said Deposited Plan Number S 3401: And whereas an open-air theatre has been constructed on Lot 3 on the said Deposited Plan Number S 3401: And whereas the dwellinghouse on Parana Park is not suitable for a children's convalescent home for patients from the Waikato Hospital: And whereas it is desirable that Parana Park and the dwellinghouse thereon should be used for other purposes for the benefit of the citizens of Hamilton and the residents of the surrounding district: 5 10

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows: 15

1. Short Title—This Act may be cited as the Hamilton City (Parana Park) Empowering Act 1958.

2. Power to lease or let dwelling on Parana Park—Without limiting the powers to lease or let conferred by Part XIII of the Municipal Corporations Act 1954, the Hamilton City Council is hereby authorised and empowered to lease under the Public Bodies' Leases Act 1908 or let by private contract Lot 1 on the said Deposited Plan Number S 3401 and the dwellinghouse thereon. 20 25

3. Power to grant use of other parts of Parana Park and authorise charges for admission—The Council is hereby authorised and empowered from time to time to grant the exclusive use of Lots 2 and 3, or either of them, on the said Deposited Plan Number S 3401 to such person or persons, for such times, and upon payment of such fees, as the Council may from time to time think fit, and to authorise such person or persons to make such charges as the Hamilton City Council thinks fit for admission during such times as aforesaid to the said Lots 2 and 3 or either of them. 30 35

4. Application of money received under this Act—All money received by the Council under the powers conferred by this Act shall be used towards the maintenance, upkeep, and improvement of Parana Park.
