A BILL INTITULED

AN ACT to further amend the Hokitika Harbour Act, 1905. Title.

WHEREAS it has been found expedient to exclude certain portions Preamble.  
of the Hokitika Harbour District as constituted by the Hokitika  
5 Harbour Act Amendment Act, 1906, from the said Hokitika Harbour  
District: And whereas the county districts included in the Hokitika  
Harbour District have objected to be rated: And whereas it has  
been deemed necessary to amend the said Act as follows:

BE IT THEREFORE ENACTED by the General Assembly of New  
10 Zealand in Parliament assembled, and by the authority of the same,  
as follows:—

1. This Act may be cited as the Hokitika Harbour Act 1905 Short Title.  
Amendment Act, 1907, and shall form part of and be read together  
with the Hokitika Harbour Act, 1905, and its amendments.

15 2. The Hokitika Harbour Act Amendment Act, 1906, is hereby Hokitika Harbour

amended as follows:—

(a.) As to section five thereof: By repealing the words “and  
20 when a rating proposal is carried in the harbour district,  
then the Mayor of Ross for the time being and two  
members to be elected by the electors of the Westland  
County within the harbour district.”

(b.) As to section six thereof: By repealing the words “the  
25 Borough of Ross, the Kanieri Riding of the County of  
Westland, and that portion of the Southern Riding of  
the County of Westland situate north of the Little  
Wanganui or Poerua River.”

(c.) As to subsection one of section seven thereof: By repealing  
the words “and the County of Westland within the  
harbour district.”

30 (d.) As to section thirteen thereof: By repealing the word  
“fifteen,” and substituting in lieu thereof the word  
“twenty.”

(e.) As to section fourteen thereof: By repealing all words after "a special rate of," and substituting in lieu thereof the words "not exceeding one penny halfpenny in the pound on the capital value of all rateable property in the said Borough of Hokitika, or the equivalent thereof on the unimproved value of all rateable property in the said Borough of Hokitika." 5

(f.) As to section sixteen thereof: By repealing the words "and Ross, and the said Kanieri Riding, and the said part of the Southern Riding of the said County of Westland." 10

3. All acts and things legally done under the said Act shall not be nullified or affected by the repeals or amendments herein contained.
