A BILL INTITLED

AN ACT to Incorporate the Township of Kawakawa. Title.

WHEREAS it is expedient to make provisions for the incorporation of the inhabitants of the Township of Kawakawa, other than are contained in "The Municipal Corporations Act, 1876" (hereinafter called "the said Act") : Preamble.

5 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

1. The Short Title of this Act is "The Incorporation of Kawakawa Act, 1879." Short Title.

10 2. Notwithstanding anything contained in section seventeen of the said Act, the Governor may, by Proclamation, declare the lands described in the Schedule hereto a borough under the said Act, and the Acts in force amending the same, subject to the following conditions :— Township of Kawakawa declared a Borough on certain conditions.

15 (1.) That a petition is presented to the Governor signed by not less than one hundred resident householders within the said area, praying the Governor to constitute the same a borough under the said Act ;

(2.) That no petition signed by one hundred or more resident householders within the said area is presented to the Governor, within two months after the presentation of such petition, praying him not to assent to the prayer thereof ;

20 (3.) That all the requirements of the said Act (except those contained in subsections two, three, and six, and section seventeen of the said Act) shall have been complied with.

SCHEDULE.

ALL that parcel of land in the Provincial District of Auckland, containing by admeasurement nine thousand nine hundred and sixty-four (9,964) acres, more or less. Bounded towards the North by Sections Nos. 93, 94, 95, 96, 97, 98, 99, a road, Sections Nos. 38, 40, 41, 42, a road, Sections Nos. 14, 13, 12, 9, and 2, Parish of Kawakawa; towards the East by the east side of the road which forms the part of the eastern boundary of Te Moke Block and by a right line, which forms part of said boundary, to Kakamatenga No. 1 Block; again towards the North by lines forming the northern boundary of said Kakamatenga No. 1 Block and Kakamatenga No. 2 Block, to the Kawakawa River; thence towards the North-west and North-east by the left bank of that river to a point due north of the north-east corner of Section No. 22, Parish of Ruapekapeka; thence again towards the East by a right line due South to said north-east corner; thence by lines forming the eastern boundary of said Section No. 22 to its south-east corner; thence by a right line to the north-east corner of Section No. 17; thence by lines forming the north-east and south-east boundaries of Sections Nos. 17 and 18 to a road; thence by the north-east side of that road to a point in line with the south-east boundary of Section No. 10; thence across the road, and by lines forming the south-east boundary of Section No. 10 aforesaid and Section No. 11A, Parish of Ruapekapeka, to the Tirohangi River; towards the South by a right line across that river to the north-east corner of Section No. 50; thence by that section, and the south side of the road which forms the south boundary of Section No. 51, to its south-westernmost angle at the junction of a road; again towards the East by the east side of a road from the said junction to the south boundary of the Ruapekapeka Block; again towards the South by lines forming the south boundaries of the said Ruapekapeka Block, the Coal-Mining Company's land, and again by the said Ruapekapeka Block to the Otiria River; thence towards the West by the left bank of that river to the Waipuna Block; thence by lines forming the west boundary of said block to its north-western corner; thence by a right line to the south-east corner of Section No. 126, Parish of Kawakawa; thence by said Section No. 126, a road, Sections Nos. 74 and 68, and the production of the eastern boundary of said Section No. 68 across the road: as the same is delineated on the plan deposited in the Survey Office, Auckland.
