A BILL INTITULED

An Act to amend the Local Bodies' Loans Act, 1908. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:

1. This Act may be cited as the Local Bodies' Loans Amend- short Title. ment Act, 1910, and shall form part of and be read together with the Local Bodies' Loans Act, 1908 (hereinafter referred to as the principal Act).

2. (1.) Notwithstanding anything in section seventy-three of Provision as to the New Zealand State-guaranteed Advances Act, 1909,—

(a.) Where any loan had been granted under Part II of the principal Act but only part of that loan had been paid over to the local authority before the second day of February, nineteen hundred and ten (being the date of the coming into operation of the New Zealand Stateguaranteed Advances Act, 1909), the balance of the loan unpaid on that date may be paid to the local authority in the same manner and subject to the same conditions in all respects as if the last-mentioned Act had not been passed:

(b.) Where before the said second day of February, nineteen hundred and ten, a loan under Part II of the principal Act had been made within the meaning of section fiftyseven of that Act, but no part of that loan had been paid to the local authority, that loan may be paid in the same manner and subject to the same conditions in all respects as if the New Zealand State-guaranteed Advances Act, 1909, had not been passed:

(2.) This section shall be deemed to have been in operation as 10 from the commencement of the second day of February, nineteen hundred and ten (being the date of the coming into operation of the

New Zealand State-guaranteed Advances Act, 1909).

3. (1.) Sections nine and ten of the principal Act (relating to the meeting of ratepayers) are hereby repealed.

(2.) Section eleven of the principal Act is hereby amended by omitting the words "The poll shall be taken," and substituting the words "A poll of the ratepayers shall be taken upon the proposal"; and also by omitting the words "of the said meetings," in paragraph (a) thereof, and substituting the words "publication of the 20 notice mentioned in section eight hereof."

4. (1.) If the proposal to raise a special loan is carried, the local authority may forthwith, by resolution, make and levy a special rate, in the manner prescribed by the Rating Act, 1908, to provide for the payment of interest, or interest and sinking fund, or interest 25 and principal, as the case may be, without the necessity of a special order as required by subsection one of section seventeen of the principal Act.

(2.) The provisions of the last preceding subsection shall also apply to a special rate made and levied in respect of a special loan to 30

be raised under section fifteen of the principal Act.

5. (1.) Where it is proposed to raise a special loan under the authority of paragraph (d) of section fifteen of the principal Act in respect of part of a district which is not a legal subdivision, the special roll of the ratepayers of that part shall be prepared, completed, 35 and deposited, and objections thereto shall be heard and determined. in the manner prescribed by subsection three of section three of the principal Act, save that the special roll shall be deposited for public inspection not less than seven days before any steps are taken under the said paragraph (d) of section fifteen.

(2.) Section twenty-two of the Local Bodies' Loans Amendment
