10 described in the Second Schedule hereto are at present vested in the Chairman, Councillors, and Inhabitants of the Horowhenua County in trust as gravel reserves: And whereas on the constitution of the Borough of Levin it was arranged that the said lands so vested in the Chairman, Councillors, and Inhabitants of the Horowhenua

15 County should be vested in and become the property of the Mayor, Councillors, and Burgesses of the Borough of Levin: And whereas it is expedient that the said lands described in the Second Schedule hereto should be so vested in the Mayor, Councillors, and Burgesses of the Borough of Levin, and that the Borough Council should have extended leasing-powers in respect of the said lands described in the First and Second Schedules hereto:
