A BILL INTITULED

AN ACT to vest certain Reserves in the Mayor, Councillors, and Burgesses of the Borough of Levin, and to empower *the Council of the said Mayor, Councillors, and Burgesses Borough* to lease the said Reserves and other Reserves vested in the said Borough.

Title.

WHEREAS the lands described in the *First* Schedule hereto are *duly* vested in the Mayor, Councillors, and Burgesses of the Borough of Levin in trust as reserves for municipal purposes under the provisions of the Public Reserves Act, 1881: And whereas the lands described in the *Second* Schedule hereto are ~~at present~~ vested in the Chairman, Councillors, and Inhabitants of the Horowhenua County in trust as gravel reserves: And whereas on the constitution of the Borough of Levin it was arranged that the said lands ~~se vested in the Chairman, Councillors, and Inhabitants of the Horowhenua County described in the said Schedule~~ should be vested in and become the property of the Mayor, Councillors, and Burgesses of the Borough of Levin, *and it is expedient to give effect to such arrangement*: And whereas it is expedient that the said lands described in the *Second* Schedule hereto should be so vested in the Mayor, Councillors, and Burgesses of the Borough of Levin, and that the said Borough Council should have extended leasing-powers in respect of the said lands described in the *First* and *Second* Schedules hereto:

Preamble.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Levin Borough Reserves Vesting and Empowering Act, 1907.

Short Title.

2. The land described in the *Second* Schedule hereto is hereby vested in the Mayor, Councillors, and Burgesses of the Borough of Levin.

Land vested in borough.

Power to lease.

3. The said lands described in the said First and Second Schedules are hereby declared to be real property of the Mayor, Councillors, and Burgesses of the Borough of Levin; and the Levin Borough Council is hereby authorised (anything in the Reserves Act, 1881, or any other Act to the contrary notwithstanding) to let the said lands described in the *First* and *Second* Schedules hereto under and subject to the provisions of the Municipal Corporations Act, 1900, and its amendments.
