A BILL INTITULED

An Act to vest certain Reserves in the Mayor, Councillors, and Title. Burgesses of the Borough of Levin, and to empower the Council of the said Borough to lease the said Reserves and other Reserves vested in the said Borough.

WHEREAS the lands described in the First Schedule hereto are Preamble. vested in the Mayor, Councillors, and Burgesses of the Borough of Levin in trust as reserves for municipal purposes under the provisions of the Public Reserves Act, 1881: And whereas the lands 10 described in the Second Schedule hereto are vested in the Chairman, Councillors, and Inhabitants of the Horowhenua County in trust as gravel reserves: And whereas on the constitution of the Borough of Levin it was arranged that the lands described in the said Second Schedule should be vested in the Mayor, Councillors, and Burgesses 15 of the Borough of Levin, and it is expedient to give effect to such arrangement: And whereas it is expedient that the said Borough Council should have extended leasing-powers in respect of the said lands described in the First and Second Schedules hereto:

BE IT THEREFORE ENACTED by the General Assembly of New 20 Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Levin Borough Reserves Vest- short Title. ing and Empowering Act, 1907.

2. The land described in the Second Schedule hereto is hereby Land vested in 25 vested in the Mayor, Councillors, and Burgesses of the Borough of borough. Levin.

3. The Levin Borough Council is hereby authorised (anything Power to lease. in the Public Reserves Act, 1881, or any other Act to the contrary notwithstanding) to let by way of lease the lands described in the 30 First and Second Schedules hereto under and subject to the provisions of section one hundred and ninety-two of the Municipal Corporations Act, 1900, and its amendments.
