## A BILL INTITULED

An Act to authorize the Lyttelton Harbour Board and Title. the Lyttelton Borough Council to exchange certain Lands within the Borough of Lyttelton.

WHEREAS the lands described in the First Schedule hereto, forming parts of roads or streets, are vested in the Corporation of the Borough of Lyttelton: And whereas the lands described in the Second Schedule hereto form part of lands vested in or belonging to 5 the Lyttelton Harbour Board: And whereas it has been agreed by the said Corporation and the said Lyttelton Harbour Board that it would be for their mutual benefit if they could exchange the said parcel of land:

BE IT THEREFORE ENACTED by the General Assembly of New 10 Zealand in Parliament assembled, and by the authority of the same,

1. The Short Title of this Act is "The Lyttelton Harbour Board Short Title. and the Corporation of the Borough of Lyttelton Exchange Act, 1879."

2. It shall be lawful for the Corporation of the Borough of Land conveyed to Lyttelton to convey and transfer to the Lyttelton Harbour Board, Board. their successors and assigns, the parcels of land set out in the First Schedule hereto, in exchange for the parcels of land specified in the Second Schedule hereto; and, immediately on the execution of such conveyance and transfer, the said lands shall vest in and may be used 20 and enjoyed by the said Lyttelton Harbour Board, their successors and assigns, in fee-simple, for the purposes of harbour works, as described in "The Harbours Act, 1878," freed from all rights of roadway or otherwise whatsoever.

Land conveyed to Corporation of Borough of Lyttelton in exchange.

3. It shall be lawful for the said Lyttelton Harbour Board to convey and transfer to the said Corporation of the Borough of Lyttelton, their successors and assigns, the said parcels of land specified and set out in the Second Schedule hereto, in exchange for the parcels of land set out in the First Schedule hereto; and, immediately on the execution of such conveyance and transfer, the said lands shall vest in the said Corporation and their successors, for the purposes of roads or streets.

Compensation to any private person thereby injuriously affected.

4. Should any claim for compensation be made by any private person having property to the westward of Section number two hun- 10 dred and thirty-four of the Town of Lyttelton injuriously affected by the said conveyance to the said Board, the same shall be made and determined in the manner provided by Part III. of "The Public Works Act, 1876," and in any such proceeding the Board shall be deemed to be the respondent within the meaning of the said Public 15 Works Act.

## FIRST SCHEDULE.

Lot. 7.—All that parcel of land containing three perches and eight-tenths of a perch, more or less, bounded as follows: Commencing at the westernmost extremity of the parcel of land described as Lot 6 in the First Schedule hereto; thence westerly by a line bearing 259° 7′ (magnetic), one hundred and thirty links; and from thence returning north-easterly and south-easterly along high-water mark to the commencing point.

Lot 9.—All that parcel of land containing three perches and eight-tenths of a perch, more or less, bounded as follows: Commencing at the south-westernmost extremity of the parcel of described as Lot 8 in the First Schedule hereto; thence south-westerly by line bearing 208° 31′ (magnetic), one hundred and eighty-four links; and from thence returning north-easterly and easterly along high-water mark to the commencing point.
