A BILL INTITULED

AN ACT to vest in the Mangawai Road Board the Lands in the Molesworth Township reserved as an Endowment for the Mangawai Harbour.

Title.

5 WHEREAS by public notification of the thirtieth day of January, one thousand eight hundred and sixty-four, Robert Graham, Esquire, the then Superintendent of the Province of Auckland, did reserve and set apart for the improvement of the Harbour of Mangawai the several allotments of land mentioned and set forth in the Schedule hereto; and the said lands have, by operation of "The Abolition of Provinces Act, 1875," become vested in Her Majesty:

Preamble

And whereas, there being no Harbour Board for the Mangawai Harbour, the Mangawai District Highway Board was authorised by Orders in Council, dated respectively the first day of September, one thousand eight hundred and eighty, and twenty-third day of September, one thousand eight hundred and ninety-one, to erect a wharf in the said harbour, and to charge wharfage-dues for the use thereof: And whereas the aforesaid wharf is now vested in the Mangawai Road Board, and the said Board are desirous of obtaining the lands reserved as an endowment for the improvement of the Mangawai Harbour, in aid of the maintenance and improvement of the wharf erected by them as aforesaid; and whereas such object is a legitimate one, and it is expedient to vest the said lands in the aforesaid Board accordingly:

25 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Mangawai Harbour Endowment Reserve Act, 1893." It shall be deemed to be a special Act for the purposes of "The Public Reserves Act, 1881."

2. The several allotments of land mentioned and set forth in the Schedule hereto are hereby vested in the Mangawai District Highway Board, as an endowment for the improvement of the Harbour of Mangawai, to be held by the said Board subject to the provisions of "The Harbours Act, 1878."

SCHEDULE.

MANGAWAI HARBOUR ENDOWMENT.

ALL that parcel of land in the Auckland Land District, being Allotment No. 1 of the Town of Molesworth, and containing by admeasurement 19 acres, more or less. Bounded towards the north-east by the sea; towards the south by Mangawai Harbour; towards the south-west by Allotment No. 2 of the Town of Molesworth, 1000 links; and towards the north-west by a public road, 970 links, to the point of commencement: be all the aforesaid linkages more or less. And also,

All that parcel of land in the Auckland Land District, being Allotments Nos. 41, 42, 43, and 44 of the Suburbs of Molesworth, and containing by admeasurement 144 acres 25 perches, more or less. Bounded towards the north-east and north-west by Allotment No. 37 of the Suburbs of Molesworth, 145 links and 350 links, respectively; again towards the north-east by Mangawai Harbour; towards the east by a public road, 300 links and 200 links; towards the south-east and north-east by Allotment No. 33 of the Suburbs of Molesworth, 430 links and 326 links respectively; again towards the south-east by a public road, 200 links and 1670 links; towards the south-west and again towards the south-east by Allotment No. 31 of the Suburbs of Molesworth, 200 links and 240 links respectively; again towards the south-west by a public road, 570, 597, 270, and 93 links; by Allotment No. 23 of the Suburbs of Molesworth, 200 links and 290 links; by a public road, 520 links and 510 links; by the crossing of a road 100 links wide, and again by a public road, 446, 446, 470, 600, 469, and 55 links; and towards the north-east by Allotment No. 16 of the Suburbs of Molesworth, 2850 links, to the point of commencement: be all the aforesaid linkages more or less; save and except a road 100 links wide which intersects the area hereinbefore described. And also,

All that parcel of land in the Auckland Land District, being Allotments Nos. 45, 46, 47, 48, 49, 50, 51, and 52 of the Suburbs of Molesworth, and containing by admeasurement 83 acres 3 roods and 8 perches, more or less. Bounded towards the north-east and east by Mangawai Harbour; towards the south-east by Allotment No. 53 of the Suburbs of Molesworth, 980 links: towards the south-west by a public road, 1200 and 4150 links; towards the north-west by a public road, 800 links; and towards the north-east and north-west by Allotment No. 34 of the Suburbs of Molesworth, 145 links and 400 links respectively, to the point of commencement: be all the aforesaid linkages more or less. And also,

All that parcel of land in the Auckland Land District, being Allotments Nos. 66, 77, 78, 79, 80, 81, 82, and 83, of the Suburbs of Molesworth, and containing by admeasurement 71 acres 1 rood, more or less. Bounded towards the north-east by a public road, 670, 313, 1172, and 776 links, by the crossing of a road 100 links wide, and again by a public road 310, 991, 712, 1116, and 1000 links; towards the south-west by Mangawai Harbour; and towards the north-west by a public road, 1400 links, to the point of commencement: be all the aforesaid linkages more or less; save and except a road-line, 100 links wide, which intersects the area hereinbefore described.
