A BILL INTITULED

AN ACT to alter the Terms of Trust under which Title. certain Church Lands in the Town of Napier are held.

WHEREAS the several parcels of land in the Town of Napier Preamble. mentioned in the First Schedule hereto were conveyed to Trustees, duly appointed under the authority of the General Synod of the Church of England of New Zealand, to hold the said lands unto

- 5 the said Trustees and their successors, and that they should stand seised of and interested in the said land upon trust to permit the same to be used as a site for a church, parsonage, and school, and any or either of them, and for no other purpose whatsoever : And whereas a school has been erected on a portion of the said land, and, in conse-
- 10 quence of the parish church of St. John's, Napier, and the parsonage, having been erected on land contiguous to the said land, the remaining portion is not required for the purpose originally intended : And whereas it is expedient that the terms of the said trust should be modified :
- BE IT THEREFORE ENACTED by the General Assembly of New 15Zealand in Parliament assembled, and by the authority of the same, as follows :--

1. The Short Title of this Act is "The Napier Church Lands Short Title. Trust Act, 1880."

- $\mathbf{20}$ 2. It shall be lawful for the said Trustees and their successors, Alteration of terms by and with the consent of the Trust Board of the Diocese of Waiapu, of trust under wa to lease for any term not exceeding sixty years, in accordance with Second Schedule the regulations of the said General Synod, the land comprised in the Second Schedule hereto, the rents and profits derivable therefrom to
- 25 be devoted to the funds of the said Parish of St. John's; and a statement of the receipts and expenditure of the said trust shall be laid before the annual session of the Synod of the said diocese.

FIRST SCHEDULE.

ALL that piece or parcel of land in the Town of Napier, containing by admeasurement 3 roods, more or less, being the whole of Town Sections numbered 130, 131, and 132 on the Government plan of the Town of Napier. Bounded towards the North-east by Town Sections 133, 134, and part of 135 on the aforesaid plan, 250 links; towards the South-east by Town Sections 128, 127, and 126 on the aforesaid plan, 300 links; on the South-west by Church Road, 250 links; and on the North-west by Browning Street, 300 links.
