A BILL INTITLED

AN ACT to amend the Noxious Weeds Act, 1908.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

This Act may be cited as the Noxious Weeds Amendment Act, 1910, and shall form part of and be read together with the Noxious Weeds Act, 1908 (hereinafter referred to as the principal Act).</p> <p>2. Section five of the principal Act is hereby amended by adding to paragraph (c) thereof the following words: "A copy of every such special order shall be forwarded to the Minister by the local authority making the same within one month after the making thereof, and the Minister shall thereupon cause the same to be gazetted."</p> <p>3. (1.) Section nine of the principal Act is hereby amended by omitting the words "to the satisfaction of the Inspector."
(2.) Section nine of the principal Act is hereby further amended by omitting therefrom the words "at the proper season of the year," wherever those words occur in that section
(3.) Where the occupier of land is, by paragraphs (b), (c), or (d) of section nine of the principal Act, required to trim or cut any hedges on that land, or to clear the same of noxious weeds, he shall perform those duties at such times as may be directed by regulations in that behalf, and in default of such regulations, then at the proper season of the year.</p> <p>4.
