A BILL INTITULED

AN ACT to constitute the Ohura County.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the Ohura County Act, 1908. Short Title.
2. The Ohura County is hereby constituted, and shall comprise all that part of the Waitomo County described in the First Schedule hereto. Constitution of Ohura County.
- 10 3. The boundaries of the Waitomo County as altered by this Act shall be as described in the Second Schedule hereto. Boundaries of Waitomo County.
New clause.
- 15 4. From and after the coming into operation of this Act no local authority other than the Ohura County Council shall, within the limits of the said county, exercise any jurisdiction or authority over any roads, or over or in relation to any matter or thing, in respect of which jurisdiction is conferred upon a County Council under the provisions of the Counties Act, 1908, or otherwise : Jurisdiction of County Council.
- 20 Provided that nothing herein shall affect the power of the Governor to proclaim any portion of the said county a borough or town district.

FIRST SCHEDULE.

BOUNDARIES OF THE OHURA COUNTY.

ALL that area in the Taranaki Land District, commencing at the south-western corner of Block IV, Pouatu Survey District, bounded towards the west by the Clifton County to the Mokau River, and by the ~~Waitomo~~ *Awakino* County along the said Mokau River to its confluence with the Parahaka Stream ; thence towards the north-west by the said Parahaka Stream to the north-east corner of Unukaimata 5B Section 2 ; thence towards the east by a portion of the east boundary of said section to the south

side of the Parahaka Road; thence towards the north and north-east by the said Parahaka Road to its junction with the Waitewhena and Paro Roads; thence towards the north-west by the Paro Road to a point where the road turns off from Section 10, Block VI, Aria Survey District; thence towards the north generally by Sections 9 and 15, Block II, Aria Survey District, and by Section 7, Block III, Aria Survey District, to the Mokau Road; thence by the said Mokau Road across said road and by the north boundary of Section 12, Block III, Aria Survey District, and south boundary of Section 10, Block III, Aria Survey District, to where it strikes the west boundary of the Puhanga Block; thence by a portion of east boundary of Section 1, Block VIII, Aria Survey District, to survey district block-line between Blocks IV and VIII, Aria Survey District; thence by the said block-line between Blocks I, II, III, and V, VI, VII, Tangitu Survey District, to the Ongarue River; thence towards the east by the said Ongarue River to its confluence with the Wanganui River; thence towards the south-east generally by the said Wanganui River to the ~~Stratford~~ Whangamomona County boundary; thence towards the south by the ~~Stratford~~ Whangamomona County to the point of commencement.

SECOND SCHEDULE.

BOUNDARIES OF THE WAITOMO COUNTY.

Struck out.

ALL that area in the Auckland Land District bounded towards the north-east by Raglan County from the trig. station on Mahaukura, Block III, Pirongia Survey District, to the confluence of the Waipa River with the Puniu River; thence by the West Taupo County to the Taranaki Land District; thence towards the south generally by the said Taranaki Land District to the confluence of the Mangaotaki River with the Mokau River; thence towards the west by a line along the middle of the said Mangaotaki River to a point in line with the south-eastern boundary-line of Section No. 2, Block XI, Maungamangero Survey District; thence again towards the south by a right line to the said south-eastern boundary-line of the said Section No. 2; and thence by the last-mentioned boundary-line and the Puketiti Block No. 1 to a point in the middle of the Mahoenui-Kawhia Road; thence again towards the west by a line along the middle of the said Mahoenui-Kawhia Road to a point in line with the western boundary-line of Section No. 3, Block VI, Maungamangero Survey District; thence by a right line to and thence by the said western boundary-line of the said Section No. 3, and the last-mentioned line produced to the middle of the Mahoenui-Kawhia Road aforesaid; thence by a line along the middle of the said Mahoenui-Kawhia Road to the middle of the Mangaohae Stream; thence by a line along the middle of the said Mangaohae Stream to the confluence of the last-mentioned stream with the Tawarau River; thence by a line along the middle of the said Tawarau River to its confluence with the Mangarere Stream; thence by a line along the middle of the last-mentioned stream to a point in line with the south-eastern boundary-line of the Kinohaku West (Tawarau) Block; thence by a right line to the last-mentioned boundary-line, and by the said Kinohaku West (Tawarau) Block to the southernmost corner of Section No. 2, Block XI, Kawhia South Survey District, by the last-mentioned section and its south-eastern boundary-line produced to the middle of the Mangapohue Road; thence towards the north by a line along the middle of the said Mangapohue Road to a point in line with the eastern boundary-line of Section No. 4, Block XII, Kawhia South Survey District; thence again towards the west by a right line to and thence by the last-mentioned section and the abutment of a road and by Section No. 7 of the said Block XII, and by the production of the eastern boundary-line of the said Section No. 7 to the middle of a road forming the northern boundary of the said Section No. 7; thence by a line along the middle of the last-mentioned road and by a line along the middle of the Mahoe Road to a point in line with the eastern boundary-line of Section No. 5, Block VIII, Kawhia South Survey District; thence by a right line to and thence by the said boundary-line of Section No. 5 and by Section No. 4 of the said Block VIII; thence by Sections Nos. 5, 4, and 1, Block IV, Kawhia South Survey District, to the north-eastern corner of the last-mentioned section; thence by a line due north to the middle of the Awaroa Road; thence by a line along the middle of the said Awaroa Road to the Hauturu Road; and thence by a line along the middle of the last-mentioned road to the Kawhia-Pirongia Road; thence by a line along the middle of the last-mentioned road to a point in line with the north-western boundary-line of Section No. 1, Block IX, Pirongia Survey Dis-

trict; thence by a right line to and thence by the said north-western boundary-line of the said Section No. 1 to the northernmost corner of the said Section No. 1; thence by Section No. 1, Block VI, Pirongia Survey District, to the easternmost corner of the said Section No. 1, Block VI; thence by a right line to the trig. station on Te Ake-o-Hikopiro; thence by a right line to the trig. station on Mahaukura, the place of commencement; and all that area in the Taranaki Land District, bounded towards the west, north, and east by the Auckland Land District, and towards the south by the Ohura County hereinbefore described.

New.

ALL that area in the Auckland and Taranaki Land Districts, bounded towards the north-east by Raglan, Waipa, and West Taupo Counties from the summit of Pirongia Mountain to the summit of Pareora Mountain; thence towards the south generally by West Taupo County and Ohura County as described in the First Schedule hereto to the eastern boundary of Awakino County; and thence towards the west generally by Awakino and Kawhia Counties to the place of commencement.
