A BILL INTITULED

AN ACT to Make Provision for the Registration of Occupational Therapists.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority **5** of the same, as follows:---

1. This Act may be cited as the Occupational Therapy Act, 1949, and, except as otherwise expressly provided herein, shall come into force on the *first* day of *January*, nineteen hundred and *fifty*.

2. In this Act, unless the context otherwise requires,—
"Board " means the Occupational Therapy Board constituted under this Act:

"Occupational therapist", or "registered occupational therapist", means a person regi- 15 stered as an occupational therapist under this Act:

"Registrar" means the Registrar of Occupational Therapists under this Act.

PART I

Ad'MINISTRATION

3. The person who for the time being holds office in the Department of Health as the Director of the Division of Nursing under the Health Act, 1920, shall, without further appointment, be the Registrar of 25 Occupational Therapists under this Act.

4. (1) There is hereby established for the purposes of this Act a Board, to be known as the Occupational Therapy Board.

(2) The Board shall consist of—

- (a) The Director-General of Health under the Health Act, 1920:
- (b) The person who for the time being holds office in the Department of Health as the Director of the Division of Mental Hygiene under the 35 Health Act, 1920, as amended by the Health Amendment Act, 1947:
- (c) The Registrar:
- (d) A person being the Medical Superintendent of a public institution under the Mental Defec- 40 tives Act, 1911, which is for the time being approved by the Board as a training school under this Act:

(3) The members of the Board, other than those who are members by virtue of their office, shall be appointed by the Governor-General on the recommenda-

- 20 tion of the Minister of Health, and shall be appointed for a period of three years, save that any such member may from time to time be reappointed, or may be at any time removed from office by the Governor-General for disability, insolvency, neglect of duty, or
- 25 misconduct, or may at any time resign his office by writing addressed to the Registrar.

(4) If any appointed member of the Board dies, resigns, or is removed from office, the vacancy so created shall be filled in the manner in which the 30 appointment to the vacant office was originally made.

Every person so appointed shall be appointed for the residue of the term for which his predecessor was appointed.

(5) Unless he sooner vacates his office as provided 35 in the last preceding subsection, every appointed member of the Board shall continue in office until his successor comes into office, notwithstanding that the term for which he was appointed may have expired.

(6) The powers of the Board shall not be affected 40 by any vacancy in the membership thereof.

(2) The Chairman shall preside at all meetings of the Board at which he is present. If at any meeting of the Board the Director-General of Health is not present, the officer of the Department of Health authorized to attend the meeting in his stead pursuant to the *next succeeding* section shall act as the Chairman in respect of that meeting, and shall have and may exercise all the powers and functions of the Chairman for the purposes of that meeting.

6. (1) Meetings of the Board shall be held at such 10 times and places as the Chairman or the Board may from time to time appoint.

(2) At any meeting of the Board *five* members shall form a quorum.

(3) Every question before the Board shall be deter- 15 mined by a majority of the votes of the members present at the meeting of the Board.

(4) The Chairman shall have a deliberative vote, and, in the case of an equality of votes, shall also have a casting vote.

(5) In the absence from any meeting of the Board of the Director-General of Health, or the Director of the Division of Mental Hygiene, the member of the Board so absent may appoint a registered medical practitioner under the Medical Practitioners Act, 1914, 25 being an officer of the Department of Health, to attend the meeting in his stead. While any person is attending any meeting of the Board pursuant to this subsection he shall be deemed for all purposes to be a member of the Board. The fact that any person so 30 attends shall be sufficient evidence of his authority so to do.

(6) Save as expressly provided in this Act, or in any regulations thereunder, the Board may regulate its procedure in such manner as it thinks fit.

7. (1) There shall be paid out of moneys appropriated by Parliament for the purpose to the members of the Board who are not officers employed in the service of the Crown such remuneration by way of fees or allowances as may from time to time be prescribed 40 by regulations under this Act.

 - (c) To conduct examinations under this Act; to appoint examiners and make all necessary arrangements for the purposes of \mathbf{the} examinations; and to issue certificates of having passed examinations to persons entitled thereto:
 - (d) To receive applications for registration under this Act; and to authorize registration in proper cases:
 - (e) To have regard to the conduct of persons registered under this Act:
- $\mathbf{25}$ (f) Generally, within the scope of its authority, to do whatever may in its opinion be necessary for the effective administration of this Act.

PART II

REGISTRATION

9. (1) The Registrar shall keep in his office a Register of 30 register, to be called the Register of Occupational Therapists, in which shall be entered the name of every person registered under this Act, together with such other particulars as may from time to time be 35 prescribed.

(2) No entry of the name of any person shall be made in the register except pursuant to a direction of the Board.

Qualifications of applicants for registration.

10. Except as provided in this Part of this Act, every person shall be entitled to be registered as an occupational therapist under this Act who satisfies the Board—

- (a) That he is the holder of a certificate of proficiency in occupational therapy, issued before the commencement of this Act, which satisfies the Board that he is qualified as an occupational therapist; or
- (b) In the case of an applicant qualified by examination in New Zealand under this Act, that he has undergone the prescribed course of training and instruction in occupational therapy in an approved training school, or approved training schools, for occupational therapists, 15 and that he has passed the examination for occupational therapists prescribed pursuant to this Act; or
- (c) In the case of any other applicant, that he is the holder of a certificate which satisfies the 20 Board that he has undergone a course of training and passed an examination elsewhere than in New Zealand equivalent to the training and examination required in the case of occupational therapists trained in New 25 Zealand and qualified by examination under this Act.

11. (1) No person who is less than twenty-one years of age shall be registered under this Act.

(2) A person shall not be registered under this Act 30 unless that person is, in the opinion of the Board, of good character and reputation.

12. Except as may be provided by regulations under this Act, every application for registration under this Act shall be made in writing addressed to the Board, 35 and shall be accompanied by such fee as may be prescribed.

13. (1) Every person registered under this Act shall, on payment of the prescribed fee, be entitled to receive a certificate of registration under the hand 40 of the Registrar, and, in the case of a person qualified under paragraph (a) or paragraph (b) of section ten

of this Act, shall also be entitled to obtain and wear a badge of a kind approved by the Board bearing his name and the date of registration.

(2) Every person commits an offence and is liable 5 to a fine not exceeding twenty pounds who, not being a person for the time being registered under this Act, wears any such badge as aforesaid or any colourable imitation thereof.

- 14. (1) Any occupational therapist who obtains any 10 approved certificate, diploma, or licence other than that by virtue of which he is registered may apply to the in register. - 15 to the certificate, diploma, or licence in respect of which the application is made and that it is one of a kind approved by the Board for the purposes of this section, shall direct the Registrar to amend the register accordingly, and the Registrar shall thereupon, on pay-
- 20 ment of such fee as may be prescribed, insert in the register particulars of the certificate, diploma, or licence.

(2) It may be a condition of the approval by the Board for the purposes of this section of any certificate.

(3) Any approval for the purposes of this section may be at any time revoked by the Board.

(1) Every occupational therapist who at any time changes his address as appearing on the register shall, within three months thereafter, send to the Registrar a notice of his new address, and the Registrar shall thereupon correct the entry in the register relating 35 to that person accordingly.

(2) Every person who, without reasonable cause, fails to comply with the provisions of this section commits an offence and is liable to a fine not exceeding one pound.

(2) If no reply is received to that letter within three months from the posting thereof, or if the letter 5 is not delivered and is returned to the Registrar, the Registrar shall, if the Board so directs, remove from the register the name of the person to whom the letter was so sent.

(3) If any registered occupational therapist applies 10 to the Registrar to have his name removed from the register, the Registrar shall, if the Board so directs, remove the name from the register accordingly.

(4) Any person whose name has been removed from the register in pursuance of this section may apply to 15 the Registrar to have his name restored to the register and his name shall, on payment of such fee as may be prescribed, be restored to the register accordingly.

17. Every person who wilfully makes or causes to be made any false entry in or falsification of the 20 register, or procures or attempts to procure himself or any other person to be registered under this Act by making or producing or causing to be made or produced any false or fraudulent representation or declaration, either orally or in writing, commits an offence 25 and is liable to imprisonment for not more than three months or to a fine not exceeding fifty pounds.

18. If any person has been registered under this Act by reason of any false or fraudulent representation or declaration, made either orally or in writing, or if 30 any person not entitled to be registered under this Act has been so registered, the Board shall cause the name of that person to be removed from the register.

(2) The approval of any training school under this 5 section may, in the discretion of the Board, be so limited that only a defined part of the prescribed course of training and instruction may be taken at that training school.

(3) The approval of any training school by the 10 Board may be at any time revoked by the Board.

20. Subject to the provisions of the next succeeding Period of section, the period over which the course of training and instruction prescribed under this Act shall extend shall be such period as may be prescribed, being not

15 less than two years and not more than three years and six months.

21. (1) In any case where a person seeking regis- Credit for tration as an occupational therapist-

- (a) Has undergone in New Zealand, before the commencement of this Act, any period of training in occupational therapy, but is not the holder of a certificate of proficiency of the kind referred to in paragraph (a) of section ten of this Act; or
- $\mathbf{25}$ (b) Has undergone elsewhere than in New Zealand any period of training in occupational therapy but is not the holder of a certificate of the kind referred to in paragraph (c) of the said section ten,-
- 30 the Board may from time to time, in its discretion, direct that it shall not be necessary for that person to undergo and receive such portion or portions as the Board may determine of the prescribed course of training and instruction in occupational therapy.
- (2) In giving any direction under this section the 35Board may make such other modifications and impose such conditions as it thinks fit in respect of the training and instruction to be undergone by the person in respect of whom the direction is given.
- **40** (3) Every person in respect of whom any direction has been given under this section shall, when he has completed the course of training and instruction as modified by any such direction as aforesaid and com-

PART IV

MISCELLANEOUS PROVISIONS

22. (1) In this section the term "year" means the period of twelve months beginning on the first day of 10 April in any year and ending on the thirty-first day of March next following.

(2) No person registered under this Act shall in any year be entitled to practise his calling as an occupational therapist unless he is the holder of an annual practising 15 certificate issued in respect of that year.

(3) Every person who practises his calling in breach of the *last preceding* subsection commits an offence and is liable to a fine not exceeding five pounds.

(4) The Board, on application made to it for the 20 purpose by any registered occupational therapist, and on payment of the prescribed fee, shall issue to him an annual practising certificate, which shall be in force during the year in respect of which it is issued:

Provided that if at any time during the currency of 25 any such certificate the holder thereof ceases to be registered under this Act the certificate shall be deemed to be cancelled.

(5) Every person who is entitled to receive an annual practising certificate under this section shall 30 be deemed to have obtained such certificate when he has duly applied to the Board for it.

23. (1) If any registered occupational therapist is at the commencement of this Act or thereafter becomes an inmate of an institution under the Mental Defectives 35 Act, 1911, whether as a patient or as a voluntary boarder, he shall not thereafter resume the practice of his calling as an occupational therapist without a licence in that behalf granted by the Board.

(2) Every person to whom this section relates who 40 practises his calling as an occupational therapist without having obtained a licence from the Board commits an

Provided that nothing in this section shall be construed to restrict the employment in any such institution of persons undergoing a prescribed course of training.

Boards to appoint occupational therapists.

(2) The Board may, if it thinks fit, determine that the decision of the Board under this section in relation to any person shall not come into effect for such period as the Board shall fix. If within that period notice of appeal is given under the *next succeeding* section, the **5** decision of the Board shall not take effect unless and until it is confirmed by the Board of Appeal or the appeal is for any reason dismissed by the Board of Appeal:

Provided that in any such case the decision shall 10 take effect from the date of the decision of the Board of Appeal or from such other date as the Board of Appeal may fix.

(3) Before exercising its powers under this section the Board, or a committee of the Board, shall cause to 15 be served on the person concerned a notice stating that it has reason to believe that a ground exists entitling the Board to exercise its powers under this section, specifying the ground with sufficient particularity to enable him to answer it, and requiring him to appear 20 before the Board to show cause why the Board should not remove his name from the register or otherwise exercise its powers under this section.

(4) The notice under the *last preceding* subsection may require the person to whom the notice is addressed 25 to notify the Board in writing not later than some specified date before the date proposed for the hearing of the matter as to whether or not he intends to appear before the Board at the hearing to show cause. If he fails to notify his intention as required by the notice or 30 notifies the Board that he does not intend to appear, he shall not be entitled to appear and be heard except by leave of the Board granted on such conditions as to the payment of expenses or otherwise as the Board thinks fit. 35

(5) With the prior written consent of a person on whom a notice has been served under this section, and who has notified the Board that he intends to show cause why the Board should not exercise its powers under this section, a committee of the Board may hear 40 and determine the matter:

Provided that the determination of the committee shall be of no effect until it has been confirmed by the Board, which shall have power to determine that no penalty be imposed or to reduce any penalty determined 45

by the committee by suspending registration for a period or imposing a pecuniary penalty instead of removing the name of the person from the register, or by reducing any period of suspension of registration or 5 any pecuniary penalty, or by substituting a pecuniary penalty for a period of suspension.

(6) Any hearing of any matter under this section may be adjourned by the Board or the committee of the Board, as the case may be, from time to time and from 10 place to place.

(7) Every monetary penalty imposed by the Board under this section shall be recoverable as a debt due to the Crown and shall be paid into the Public Account to the credit of the Consolidated Fund. If any such pen-

- 15 alty is not paid within the time specified by the Board in that behalf, or within such extended time as the Board may allow, the Board may suspend the registration of the person liable for the payment of the penalty until the penalty is paid.
- $\mathbf{20}$ (8) While the registration of any person is suspended in accordance with this section he shall be deemed not to be registered.

26. (1) Every person who is dissatisfied with any Appeals from decision of the Board relating to an application by him decision Board.

- 25 for registration or for a licence under section twentythree of this Act, or to the removal of his name from the register, or to the suspension of his registration, or to the imposition on him of any penalty, may, within three months after notice of the decision has been communi-
- 30 cated to him by the Registrar, or within such further period as the Board either before or after the expiration of the said three months may allow, give notice of appeal in the prescribed manner to the Registrar.
- (2) Upon receipt of the notice of appeal the 35 Registrar shall take all steps necessary for the constitution of a Board of Appeal, consisting of a Magistrate and two assessors. The assessors shall be appointed in accordance with regulations under this Act to represent the Board and the appellant respectively.
- (3) The Board of Appeal so constituted shall as 40soon as practicable hear the appeal, and may confirm, reverse, or modify the decision of the Board, and may give any decision which the Board could have given under subsection one of the last preceding section.

(4) On any appeal under this section the decision of not less than two members of the Board of Appeal (including the Magistrate) shall be the decision of that Board, and that decision shall be final and conclusive.

(5) On any appeal under this section the Board of 5 Appeal may make an order for the payment by the Board, or by the appellant, of the costs incurred in respect of the appeal by the other party to the appeal, and in any such case the costs so awarded may be recovered in any Court of competent jurisdiction as a 10 debt due by the party against whom they have been awarded to the party in whose favour they have been awarded.

27. Every person commits an offence and is liable to a fine not exceeding ten pounds who, not being registered 15 under this Act,—

- (a) Wears the uniform or any distinctive part of the uniform prescribed for registered occupational therapists under this Act:
- (b) Uses any name, title, addition, or description 20 intended or likely to cause any person to believe that he is registered under this Act.

28. Every person commits an offence and is liable to a fine not exceeding twenty pounds who describes himself or otherwise holds himself out as a teacher of 25 occupational therapy, or in any manner intended or likely to cause any other person to believe that he is qualified to give instruction to or to train persons in occupational therapy, unless he is previously authorized in writing by the Board to give instruction or train 30 persons as aforesaid.

29. All proceedings in respect of offences against this Act or against any regulations made under this Act shall be taken in a summary way.

30. A certificate under the hand of the Registrar to 35 the effect that any person is or is not registered or the holder of an annual practising certificate under this Act, or was or was not so registered or the holder of such a certificate at any particular time or during any period specified in the certificate, or as to any entry in the 40 register kept under this Act, or as to any act or proceeding of the Board or any committee of the Board, shall, until the contrary is proved, be sufficient evidence of the matters therein specified.

- (f) Prescribing the conditions under which any hospital or other institution may be recognized as an approved training school for the purposes of this Act:
- (g) Prescribing the number of persons that may be undergoing a prescribed course of training and instruction at any one time, or accepted for training and instruction in any one year, in any approved training school:
