A BILL INTITULED

An Act to change the Name of the Petone and Lower Title. Hutt Gas-lighting Board and to increase the Unauthorized Expenditure of the Board from Fifty Pounds to One Hundred Pounds per Annum.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Petone and Lower Short Title. 10 Hutt Gas Amendment Act, 1944, and shall be read together with and deemed part of the Act heretofore known as the Petone and Lower Hutt Gas-lighting Act, 1922 (hereinafter referred to as the principal Act).

2. (1) The principal Act may hereafter be cited as Altering titles 15 the Petone and Lower Hutt Gas Act, 1922.

Change of name of Board established under principal

3. (1) The name of the Board established under the principal Act is hereby changed, and the said Board shall hereafter be called the Petone and Lower Hutt Gas Board.

(2) The change of name shall not affect any rights 20 or obligations of the Board, or render defective any legal proceedings by or against the Board, and any legal proceedings that might have been continued or commenced against it by its former name may be continued or commenced against it by its new name. 25

Increasing unauthorized expenditure to £100.

4. (1) Section ten of the Petone and Lower Hutt Gas Amendment Act, 1927, as amended by section five of the Petone and Lower Hutt Gas Amendment Act, 1933, is hereby further amended by substituting—the words - "one hundred pounds" - for the words "fifty 30 pounds-"- omitting the words "fifty pounds", and substituting the words "one hundred pounds".

Repeal.

(2) Section five of the Petone and Lower Hutt Gas Amendment Act, 1933, is hereby consequentially repealed.

(3) This section shall be deemed to have come into 35 force on the first day of April, nineteen hundred and forty-three.
