An Act to amend the Law relating to Partition.

BE IT ENACTED by the General Assembly of New Zealand, in Parliament assembled, and by the authority of the same as follows:-

1. The Short Title of this Act shall be "The Partition Act, Short Title. 5 1870."

2. In this Act the term "the Court" means the Supreme Court As to the term "the Court." of New Zealand.

In a suit for partition where if this Act had not been passed a decree for partition might have been made then if any party interested in the property to which the suit relates requests the Court to direct a sale of the property and a distribution of the proceeds instead of a division of the property between or among the parties interested the Court may if it thinks fit unless the other parties interested in the property or some of them undertake to purchase the share of the party 10 requesting a sale direct a sale of the property and give all necessary or proper consequential directions and in case of such undertaking being given the Court may order a valuation of the share of the party requesting a sale in such manner as the Court thinks fit and may give all necessary or proper consequential directions.
