## POULTRY BOARD ACT REPEAL BILL

#### **EXPLANATORY NOTE**

THIS Bill dissolves the New Zealand Poultry Board, and provides for the vesting, in the Crown, of the assets and liabilities of the Board. The Poultry Board Act 1980 is consequentially repealed.

Clause 1 relates to the Short Title and commencement. The Bill is to come into force on 20 December 1988.

Clause 2 dissolves the New Zealand Poultry Board, and provides for the vesting, in the Crown, of the assets and liabilities of the Board.

Clause 3 repeals the Poultry Board Act 1980, and effects certain consequential repeals.

Clause 4 effects certain consequential amendments.

### A BILL INTITULED

# An Act to abolish the New Zealand Poultry Board

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Poultry Board Act Repeal Act 1988.
  - (2) This Act shall come into force on the 20th day of December 1988.
- 2. Dissolution of New Zealand Poultry Board—(1) In this section, "Board" means the New Zealand Poultry Board 10 continued by section 4 of the Poultry Board Act 1980.
  - (2) On the commencement of this Act—
  - (a) The New Zealand Poultry Board shall be dissolved and the term of office of every member of the Board shall cease:
- 15 (b) All real and personal property belonging to the Board shall become vested in the Crown subject to all liabilities, charges, obligations, or trusts affecting that property:
- (c) All money payable to the Board shall become payable to and be recoverable by the Crown:
  - (d) All liabilities and obligations, and all rights and authorities of any nature whatever of the Board shall become liabilities, obligations, rights, and authorities of the Crown:

- (e) All proceedings pending by or against the Board may be carried on, completed, and enforced by or against the Crown.
- **3. Repeals**—The following enactments are hereby repealed:

- **4. Consequential amendments**—(1) The Ministry of Agriculture and Fisheries Act 1953 is hereby consequentially 15 amended by omitting from the First Schedule (as substituted by section 4 (1) of the Ministry of Agriculture and Fisheries Amendment Act 1972) the reference to the Poultry Board Act 1980.

(2) The Public Bodies Contracts Act 1959 is hereby 20 consequentially amended by omitting from Part II of the First Schedule the item relating to the New Zealand Poultry Board.

- (3) The Higher Salaries Commission Act 1977 is hereby consequentially amended by omitting from the First Schedule (as substituted by section 14 of the Higher Salaries Commission 25 Amendment Act 1988) the item relating to the New Zealand Poultry Board.
- (4) The Official Information Act 1982 is hereby consequentially amended by omitting from the First Schedule (as substituted by section 23 (1) of the Official Information 30 Amendment Act 1987) the item relating to the New Zealand Poultry Board.
