AN ACT to amend "The Public Domains Act, 1881."

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

A local authority any of whose members are <i>ex officio</i> members of a Domain Board may apply any part of its ordinary funds towards the management, improvement, and maintenance of any lands the control of which is delegated to that Board under "The Public Domains Act, 1881," notwithstanding that such lands may be situate outside the district of such local authority.</p> | <p>Local authority may assist Domain Board with funds.</p> |
| <p>3. No portion of any domain used for public recreation shall be leased for building purposes <del>except with the consent of the Minister of Lands previously obtained.</del></p>   | <p>Domains not to be let for building.</p>                 |
