## A BILL INTITULED

An Act to amend the Police Force Act 1947.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority 5 of the same, as follows:

1. This Act may be cited as the Police Force Amend- Short Title. ment Act 1955, and shall be read together with and deemed part of the Police Force Act 1947 (hereinafter 1947, No. 13 referred to as the principal Act).

2. In this Act, unless the context otherwise requires,-Interpretation. "Chairman" means the Chairman of the Police Commission:

"Commission" means the Police Commission established by this Act.

3. (1) There may from time to time be appointed a Police Commission to be called the Police Commission.

(2) The Commission shall consist of not more than five persons, who shall be appointed by the Governor-General in Council and, except as otherwise provided by this section, shall hold office during the pleasure of the Governor-General in Council.

(3) Any person who is not a member of the Force shall

be eligible for appointment to the Commission:

Provided that not more than two such persons shall at any time be members of the Commission.

(4) Any person appointed under subsection three of this section shall hold office as a member of the Commission during the pleasure of the Governor-General in Council or for a term, not exceeding five years, to be specified in that behalf.

(5) One of the members of the Commission shall be appointed by the Governor-General in Council as the Chairman of the Commission. The Chairman shall hold office as such during the pleasure of the Governor-General in Council or for a term, not exceeding five years, to be specified in that behalf.

(6) The Chairman or any member of the Commission appointed under subsection three of this section may be removed from office by the Governor-General in Council

for misbehaviour or incompetence.

(7) If any member of the Commission dies, or resigns, or is removed from office, the vacancy so created may be filled in the manner in which the appointment to the vacant office was originally made.

(8) The powers of the Commission shall not be affected

by any vacancy in its membership.

(9) The Commission may regulate its procedure in

such manner as it thinks fit.

4. (1) In any case in which the Minister is satisfied that the Chairman or any other member of the Commission is incapacitated by illness, absence, or other sufficient cause from performing the duties of his office, the Minister may appoint a deputy to act for the Chairman or for that other member during his incapacity. In the case of the incapacity of the Chairman his deputy may or may not be one of the other members, and if the 40 deputy of the Chairman is one of the other members some other person may be appointed to act as the deputy of that member.

(2) Any deputy appointed under this section shall, while he acts as such, be deemed to be a member of the Commission and the deputy of the Chairman shall have all the powers of the Chairman.

(3) No appointment of a deputy, and no acts done by him as such, shall in any proceedings be questioned on the ground that the occasion for his appointment had not

arisen or had ceased.

5. The functions of the Commission shall be to advise 10 the Chairman on all matters referred to it by the Chairman and to carry out such other duties in connection with the general administration of the Force as may be as-

signed to it from time to time.

6. (1) While the Commission remains in existence, all Powers and 15 the powers and duties conferred or imposed on the Commissioner by the principal Act or by any other Act shall be carried out by the Chairman and not by the Commissioner, and all references to the Commissioner in any Act, regulation, by-law, Order, or other enactment or in any 20 deed, instrument, application, licence, notice, or other document shall, unless inconsistent with the context, be read as references to the Chairman.

(2) Notwithstanding the provisions of any enactment, any office held by the Commissioner by virtue of his office 25 shall, while the Commission remains in existence, be held

by the Chairman.

2. (1) The Governor-General may from time to time Controllerappoint a fit and proper person to be Controller-General 30 of the Police Force.

(2) The Governor-General may from time to time General of Police Force, appoint an Assistant Commissioner to be Deputy Con-

troller-General of the Police Force.

(3) The Controller-General and the Deputy Controller-General shall each hold office during the pleasure of the Governor-General.

3. (1) While the Controller-General is in office, all Powers and the powers and duties conferred or imposed on the Commissioner by the principal Act or by any other Act 40 shall be carried out by the Controller-General and not by the Commissioner, and all references to the Commissioner in any Act, regulation, by-law, Order, or other

enactment or in any deed, instrument, application, licence, notice, or other document shall, unless inconsistent with the context, be read as references to the Controller-

(2) Notwithstanding the provisions of any enactment, any office held by the Commissioner by virtue of his office shall, while the Controller-General is in office, be held

by the Controller-General.

4. (1) The Deputy Controller-General, subject to the control of the Controller-General, shall have and may 10 exercise all the powers, duties, and functions of the Controller-General.

(2) On the occurrence from any cause of a vacancy in the office of Controller-General (whether by reason of death, resignation, or otherwise), and in case of the 15 absence from duty of the Controller-General (from whatever cause arising), and so long as any such vacancy or absence continues, the Deputy Controller-General shall have and may exercise all the powers, duties, and functions of the Controller-General.

(3) The fact that the Deputy Controller-General exercises any power, duty, or function of the Controller-General shall be conclusive evidence of his authority to

do so.

7. All acts done before the commencement of this Act 25 by the Commission of Police Officers appointed on the twenty-second day of December, nineteen hundred and fifty-four, for the purpose of controlling the administration of the Force are hereby validated.

8. (1) The principal Act is hereby amended by insert- 30 ing, after section three A, as inserted by subsection one of section two of the Police Force Amendment Act 1954, the following section:

"3B. The Commissioner shall hold office during the

pleasure of the Governor-General."

(2) Section sixteen of the principal Act, as amended by subsection three of section two of the Police Force Amendment Act 1954, is hereby further amended by omitting the words "discharge or dismiss the Commissioner or any Assistant Commissioner, Superintendent", 40 and substituting the words "dismiss from the Force any Assistant Commissioner, Superintendent".

"3c. On the termination of the appointment of any person as Commissioner, [or as Chairman of the Police Com-15 mission, or as a member of the Commission who is not a member of the Force,] or as Controller-General, otherwise than by his removal from office for misbehaviour or incompetence, he shall, unless he is appointed to another position in the Government service, or has declined to 20 accept any such appointment, or is not a contributor to the Government Superannuation Fund, be entitled to receive from the Fund an annual retiring allowance for the rest of his life computed as provided in section thirty- 1947, No. 57 one of the Superannuation Act 1947, notwithstanding 25 that he may not have attained the age or have had the length of service which would entitle him in accordance

11. Whereas Commissioner Eric Henry Compton re- Provision for tired from the office of Commissioner of Police on the Commissioner nineteenth day of April, nineteen hundred and fifty-five: E. H. Compton [And whereas it is expedient to make provision to give on his effect to the terms of his retirement: Be it therefore 40 enacted as follows:

(1) There shall be paid to him out of the Consolidated Fund, without further appropriation than this section,—

(a) Three months' salary for accumulated leave due to him:

(b) Six months' salary for leave on retirement:

(c) The sum of six thousand pounds as compensation

for loss of office.

(2) Notwithstanding anything to the contrary in the Superannuation Act 1947, he shall be entitled to receive from the Government Superannuation Fund an annual retiring allowance from the nineteenth day of January, nineteen hundred and fifty-six, for the rest of his life at the rate of eight hundred and twelve pounds a year.
