A BILL INTITULED

An Act respecting the Government of Provinces.

BE it enacted by the General Assembly of New Zealand in Parliament assembled and by the second secon ment assembled and by the authority of the same as follows:-

1. The Short Title of this Act shall be "The Provincial Govern- Short Title. ments Act 1871.

2. The Superintendent for the time being of the several Provinces of Superintendents of Auckland Taranaki Wellington Nelson Canterbury and Otago shall by virtue of his office of Superintendent and so long as he holds the same be a Member of the Provincial Council of the Province of which he is

In Taranaki Hawke's Bay Marlborough number of Members of Provincial Councils not to be enlarged. 4. The number of Members to be returned to the Provincial Council of such Province by each of such districts respectively shall be such number of Members as by the law for the time being in force such districts respectively return to the House of Representatives and as to Electoral Districts for the House of Representatives of which only a part and not 5 the whole lies within such Province then the number of Members to be returned to the Provincial Council for such part shall be such number as shall be fixed by Order in Council not exceeding the number of Members returned for the whole district to the House of Representatives.

5. Upon and after such repeal as aforesaid the electoral rolls for the 10 time being in force for the election for the several Electoral Districts within any of the Provinces aforesaid of Members of the House of Representatives shall be the electoral rolls for the election for such districts of Members of the Provincial Council of such Province but as to the electoral rolls for any Electoral Districts for the election of Members 15 of the House of Representatives not wholly contained within such Province the Registration Officer appointed for the part of such district lying within such Province and which part is hereby constituted an Electoral District for the election of Members of the Council of such Province shall whenever an electoral roll from time to time comes in 20 force for the whole Electoral District for the election of Members of the House of Representatives form therefrom for such part an electoral roll for the election of Members of the Provincial Council and for that purpose the name of every elector on the roll for the time being in force for the whole district whose qualification is in respect of lands or tene- 25 ments situate within the part of the district lying within the Province shall be placed on the roll for such part and from such rolls shall be formed the roll for the election of the Superintendent of such Province.

6. The Governor whenever he dissolves the Provincial Council of any Province may if he think fit in and by the Proclamation whereby 30 he dissolves such Council declare that notwithstanding such dissolution there shall not on the occasion thereof be a new election of a Superintendent of such Province and in case such declaration shall be made the person who shall be in office as Superintendent of such Province at the time of such Proclamation shall notwithstanding such dissolution continue in office until the termination of such Council by effluxion of time or by a subsequent dissolution or until the death resignation removal or disqualification of such person.

7. Whenever it appears to the Governor that on account of the existence of disagreements between the Superintendent of any Province 40 and the Provincial Council of such Province or for other reasons a new election of a Superintendent should be held without a dissolution of the Council the Governor may instead of dissolving such Council by Proclamation published in the New Zealand Gazette direct that a new election of a Superintendent of such Province shall be held and 45 thereupon a new election shall be held and the like proceedings had as in the case of a vacancy by resignation of such Superintendent accepted by the Governor but the Superintendent in office at the time of making such Proclamation shall remain in office till the election of his successor.

8. In the Provinces of Taranaki Hawke's Bay and Marlborough 50 respectively the number of Members of which the Provincial Councils thereof by law now consist shall not be enlarged except by Act of the General Assembly.
