AN ACT to amend "The Public Health Act, 1876."

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

| <p>1. The Short Title of this Act is "The Public Health Act 1876 Amendment Act, 1880."</p> <p>5 2. Notwithstanding anything contained in "The Public Health Act, 1876," or any Act amending the same, the Christchurch Drainage Board, constituted by "The Christchurch District Drainage Act, 1876," 1875," may, within and so far as the City of Christchurch is concerned, by resolution passed by a majority of the members of the said Board, delegate all or any of the powers conferred upon such Board as the Local Board of Health for the district constituted by the second section of "The Christchurch District Drainage Act, 1875," to the Christchurch City Council, any City or Borough Council or Road Board, and such delegation may from time to time revoke.</p> <p>10</p> <p>15 3. Upon every such delegation the said City or Borough Council or Road Board shall have, exercise, and perform, within the limits of the City of Christchurch, its jurisdiction, all or any of the powers, rights, and duties given by "The Public Health Act, 1876," and any Acts amending the same, and which may have been delegated to the said Council; such body or bodies as aforesaid; and no other Local Board of Health shall have, exercise, or perform any powers, rights, and duties which shall or may obstruct or interfere with the powers, rights, or duties so delegated and exercisable by the said City Council bodies upon such delegation and during the continuance thereof.</p> <p>20</p> <p>25 4.
