1 Title

- (1) This Act is the Parental Leave and Employment Protection Amendment Act (No 2) **2005**.

Section 71B(3) of the principal Act is amended by inserting, 10 after the word "spouses", the words "or partners".

57D Entitlement may be transferred to spouse

Section 71E(3) of the principal Act is amended by repealing paragraph (a), and substituting the following paragraph:

"(a) references in this Part to the employee's entitlement to a 15 parental leave payment are references to the entitlement of the employee's spouse or partner to a parental leave payment; and".

Section 71H(1) of the principal Act is amended by inserting, 20 after the word "spouses" in both places where it appears, the words "or partners".

The provisions of the principal Act specified in **Schedule 6A** are amended by inserting, after the word "spouse" wherever it 25 appears, the words "or partner".
