## AN ACT to amend the Law relating to Promissory Title. Oaths.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows—

- 1. The Short Title of this Act shall be "The Promissory Oaths Short Title. Act 1870."
- 5 2. The oath in this Act referred to as the Oath of Allegiance Oath of Allegiance. shall be in the form following that is to say
  - do swear that I will be faithful and bear true allegiance to Her Majesty Queen Victoria Her Heirs and successors according to law So help me GOD.
- 10 3. The oath in this Act referred to as the Official Oath shall be Official Oath. in the form following that is to say
  - do swear that I will well and truly serve Her T Majesty Queen Victoria in the office of So help me God.
- 15 4. The oath in this Act referred to as the Judicial Oath shall be Judicial Oath. in the form following that is to say
  - do swear that I will well and truly serve Our Sovereign Lady Queen Victoria in the office of
  - and I will do right to all manner of people after the laws and usages of this Colony without fear or favour affection or ill will So help me GOD.

Executive Councillor's Oath. 5. The oath in this Act referred to as the Executive Councillors Oath shall be in the form following that is to say—

being chosen and admitted of the Executive Council in New Zealand do swear that I will to the best of my judgment at all times when thereto required freely give 5 my counsel and advice to the Governor Lieutenant-Governor or Officer Administering the Government of New Zealand for the time being for the good management of the affairs of New Zealand That I will not directly nor indirectly reveal such matters as shall be debated in 10 Council and committed to my secrecy but that I will in all things be a true and faithful Councillor So help me GOD.

6. The Oath of Allegiance and the Executive Councillor's Oath shall be taken by every person admitted of the Executive Council of 15 the Colony as soon as may be after his acceptance of office and such oaths shall be tendered by the Clerk of the Executive Council or officer for the time being acting as Clerk of the Executive Council in the presence of the Governor or otherwise as the Governor shall direct at a meeting of the Executive Council. 20

7. The Oath of Allegiance and Judicial Oath shall be taken by each of the officers named in the First Schedule hereto as soon as may be after his acceptance of office and such oaths shall be tendered and taken in manner in which the oaths required to be taken by such officer previously to the passing of this Act would have been tendered 25 and taken or in such manner as the Governor shall from time to time direct.

8. The Official Oath shall be tendered to and taken by each of the officers named in the Second Schedule hereto as soon as may be after his acceptance of office by the officer and in the manner in that 30 behalf mentioned in the said Schedule.

9. If any officer mentioned in this Act or in the Schedule hereto declines or neglects when any oath required to be taken by him under this Act is duly tendered to take such oath he shall if he has already entered on his office vacate the same and if he has not entered 35 on the same be disqualified from entering on the same but no person shall be compelled in respect of the same appointment to the same office to take any oath or make any affirmation more times than one.

10. The form of the Oath of Allegiance provided by this Act shall be deemed to be substituted in the case of "The Aliens Act 40 1866" for the form of the Oath of Allegiance therein prescribed to be taken and all the provisions of the said Act shall apply to the oath substituted by this section in the same manner as if that form of oath were actually inserted in the Schedule to the said Act in the place of the oath for which it is substituted. 45

11. No person shall be required or authorized to take the Oaths of Allegiance Supremacy and Abjuration or any of such oaths or any oath substituted for such oaths or any of them or to make any declaration to the like effect of such oaths or any of them except so far as regards the oath referred to in this Act as the Oath of Allegiance 50 the persons required to take the Oath of Allegiance by this Act and the Constitution Act and "The Aliens Act 1866" or one of such Acts any Act Ordinance Statute or Charter to the contrary notwithstanding.

12. Where in any oath under this Act the name of Her present Majesty is expressed the name of the Sovereign of the United King- 55 dom for the time being shall be substituted from time to time.

13. When any oath is required to be taken under this Act every person for the time being by law permitted to make a solemn affirmation or declaration instead of taking an oath may instead of taking such oath make a solemn affirmation in the form of the oath 60

Where in any case not provided for by this Act or included Declaration to be within the saving clauses thereof any person would by virtue of any taken instead of law now in force be required to take any oath on or as a condition of cases. 5 his accepting any employment or office or being admitted to any rights or privileges a declaration shall be substituted for such oath in such form as the person who would have administered such oath shall 10 think fit but so that the declaration be to the like effect in all respects

as the oath for which it is substituted.

15. The making a declaration in pursuance of the last preceding Effect of such section shall in all respects have the same effect as the taking the declaration. oath for which the same is substituted would have had if this Act had

16. If any person required by this Act to make a declaration Effect of neglecting instead of an oath declines or neglects to make such declaration he to make declaration. shall be subject to the same penalties and disabilities if any as he would have been subjected to for declining or neglecting to take the

- 20 oath for which the declaration provided by this Act is substituted. 17. Nothing in this Act shall affect—
  - (1.) Any oath prescribed by the Constitution Act.
  - (2.) Any oath required to be taken by members of the Armed Constabulary Force the Militia or the Volunteers.
  - (3.) "The Aliens Act 1866" except as to the form of oath thereby required to be taken.
  - (4.) The eighteenth section of "The Merchant Shipping Act 1854" except that the form of the Oath of Allegiance prescribed by this Act shall be administered in lieu of any other form of oath heretofore used under the provisions of the said section.
  - (5.) Any oath required or authorized by any law in force in this Colony for the purpose of attesting any fact or verifying any account or document.
  - (6.) Any oath required to be taken by any juror witness or other person in pursuance of any law rule usage or custom as preliminary to or in the course of any civil criminal military or other trial inquest or proceedings of a judicial nature including any arbitration or as preliminary to or in the course of any proceedings before a Committee of the Legislative Council or House of Representatives or a Joint Committee of the said Legislative Council and House of Representatives or before any Commissioner or other special tribunal appointed by the Governor.
- 18.
