A BILL INTITULED

AN ACT to declare certain Provincial Ordinances to continue in Title. force, and for the Repeal of all other such Ordinances.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows :--

1. The Short Title of this Act is "The Provincial Ordinances Short Title. Act, 1892."

2. In this Act—

"Province" means any of the former Provinces of Auckland, Taranaki, Hawke's Bay, Wellington, Nelson, Marlborough, Canterbury, Westland, Otago, or Southland;

"Provincial Ordinance" means an Act or Ordinance passed by the Superintendent of any former province with the advice and consent of the Provincial Council thereof.

15 3. Saving and excepting as to the Provincial Ordinances and ordinances reparts of Ordinances severally enumerated in the Schedule hereto, all pealed. Provincial Ordinances are hereby repealed.

4. "The Provincial Laws Evidence Act, 1877," is hereby Provincial Laws repealed.
