A BILL INTITULED

AN ACT to prevent Corrupt Practices in Parliament. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :

1. The Short Title of this Act is "The Prevention of Corruption Short Title. 5 Act, 1879.'

2. Every person who gives, or offers to give, a bribe to any Attempt to corruptly member of the New Zealand Assembly, or to another person for him, influence member or attempts, by menace, deceit, suppression of truth, offer or promise imprisonment.

- punishable by imprisonment for not less than one nor more than years.

- asks, receives, or agrees to receive, or becomes a party to receiving, party to such corrupt 20 any bribe, or the gift of any office, or who becomes a party to any of imprisonment. the offences or corrupt practices set forth in the preceding section, upon any understanding that his official vote, opinion, judgment, or action shall be influenced thereby, or shall be given in any particular manner, or upon any particular side of any question or matter upon
- 25 which he may be required to act in his official capacity, or gives, or offers, or promises to give, any official vote in consideration that another member of the Assembly shall give any such vote, either upon the same or another question, shall be punishable by imprisonment for not less than one nor more than years.

Every person who, being summoned to attend as a witness Witness refusing to 30 before either house of the Legislature or any Committee thereof, attend or give evidence before either refuses or neglects, without lawful excuse, to attend pursuant to such House of Legislature summons, and every person who, being present before either House of without lawful excuse, guilty of a the Legislature, or any Committee thereof, wilfully refuses to be sworn misdemeanour.
- 35 or to answer any material and proper question, or to produce upon reasonable notice any material and proper books, papers, or documents in his possession or under his control, is guilty of a misdemeanour.

5. Every member of the General Assembly of New Zealand con-Disgualification. victed of any offence defined, set out, or contained in this Act shall, in

40 addition to the punishment herein prescribed, forfeit his seat and office and be for ever disqualified from becoming again a member of the said General Assembly, or of holding any office under the Government of this colony.
