A BILL INTITULED

AN ACT to make further provision for securing the Title. Freedom and Independence of Parliament.

 ${f B}^{\rm E}$ IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act shall be "The Provincial Officers Short Title. Б Disqualification Act, 1873."

2. - Provided however that no person being now a Member of the Present Members of said House of Representatives, and now holding any such office House of Represent as aforesaid, shall be deemed to be disqualified from continuing Superintendents 20to sit or vote, or from sitting or voting, in such House, by reason exempted. only of his holding the said office; but this exemption shall continue
- 25 in force with regard to such person only until the dissolution of the General Assembly, or the expiration thereof by lapse of time, or until the seat of such Member becomes otherwise vacant, whichever shall

first happen; and also as to any such Superintendent of a Province, this exemption shall continue only until his office of Superintendent becomes vacant by the dissolution or expiration of the Provincial Council of such Province, or by resignation of office or otherwise, but shall not continue afterwards though the person now being Superin- 5 tendent be re-elected to be Superintendent.

3. If any person hereby disqualified or declared incapable of being elected a Member of the House of Representatives is nevertheless elected and returned as a Member of the said House, his election and return shall be null and void.

4. If any Member of the Legislative Council or House of Representatives shall, by accepting any office, become disqualified under the foregoing provisions from continuing to sit or vote in the said Council or House, the seat of such Member shall thereby be vacated, and if a Member of the House of Representatives, his election shall thenceforth 15 be void.

5. If any person disqualified or declared incapable of sitting or voting, or continuing to sit or vote, in the Legislative Council or House of Representatives by any of the provisions hereinbefore contained, shall presume to sit or vote therein, he shall thereby forfeit the sum 20 of one hundred pounds for each and every day on which he so sits or votes, and such sum may be recovered from him by any person who may sue for the same in any Court of competent jurisdiction in New Zealand.

6. Every Superintendent of a Province elected to be such after 25 the passing of this Act shall, by virtue of his office and without being summoned, be a Member of the Legislative Council, and be entitled to sit and vote therein so long as he holds such office as if summoned to the said Council.
