A BILL INTITULED

An Act to validate and confirm certain regulations made under the Primary Products Marketing Act 1953

WHEREAS by sections 3 and 4 of the Primary Products
Marketing Act 1953 (hereinafter referred to as the Act) it is provided that all regulations made under the Act shall be laid before Parliament and shall expire on the last day of the session in which they are laid except so far as they are expressly validated or confirmed by an Act of Parliament

2 Primary Products Marketing Regulations Confirmation

1. Short Title—This Act may be cited as the Primary Products Marketing Regulations Confirmation Act 1978.

2. Regulations confirmed—The regulations specified in the Schedule to this Act, and the amendments to the Honey Marketing Authority Regulations 1975 effected by section 5 14 of the Hive Levy Act 1978, are hereby declared to be valid and are hereby confirmed as required by section 4 of the Act.

3. Repeals—The following enactments are hereby repealed:
