

PRIMARY PRODUCTS MARKETING REGULATIONS CONFIRMATION BILL

EXPLANATORY NOTE

THIS Bill validates and confirms regulations made under section 3 of the Primary Products Marketing Act 1953 and laid before Parliament during the present session. Unless so confirmed, the regulations will, by virtue of section 4 (1) of that Act, expire with the close of the last day of this session.

The regulations validated and confirmed are as follows:

1. The Honey Marketing Authority (Dissolution) Regulations 1983, which provide for the dissolution of the Authority after the payment of its debts, and for the transfer of the balance of its property to 2 trusts established to advance the honey industry in New Zealand:

2. The Kiwifruit Marketing Licensing Regulations 1977, Amendment No. 2, which extended the duration of kiwifruit exporter's licences (that would otherwise have expired on 31 March 1983) until 31 March 1984:

3. The Kiwifruit Marketing Licensing Regulations 1977, Amendment No. 3, which made numerous minor amendments to the procedures, functions, and powers of the Kiwifruit Authority, and a major amendment which substituted a new licensing procedure for kiwifruit exporters and instituted an expanded system of appeals:

4. The Berryfruit Marketing Licensing Regulations 1983, which established an export market licensing authority for the export of blackcurrants and boysenberries.

1. Short Title—This Act may be cited as the Primary
Products Marketing Regulations Confirmation Act 1983.

Schedule to this Act are hereby declared to be valid and are
hereby confirmed as required by section 4 of the Primary
Products Marketing Act 1953.

3. Repeal—The Primary Products Marketing Regulations
Confirmation Act 1982 is hereby repealed.
