A BILL INTITULED

An Act to transfer to the Governor in certain events Title. the Powers conferred on Superintendents.

Parliament assembled and by the Parliament assembled and by the Seneral Assembly of New Zealand in Parliament assembled and by the authority of the same as follows:

1. The Short Title of this Act shall be "The Provincial Powers Short Title. Transfer Act 1871."

2. If the Provincial Council of any Province shall by resolution passed by a majority of Members present at a meeting of such Council signify its opinion that it is inexpedient for such Council to continue to provide or apply necessary means to meet the expenditure for the 5 administration of the local government of such Province generally and that all the powers and duties conferred or imposed on the Superintendent of such Province either solely or acting with the advice and consent of the Executive Council of such Province by any Act of the General Assembly or any Act or Ordinance of the Superintendent 10 and Provincial Council of such Province should cease to be exercised or performed by the Superintendent of the Province and if a copy of the resolution so passed be by the order of such Provincial Council forwarded to the Superintendent of such Province and be afterwards

transmitted to the Governor by the Superintendent of such Province 15 accompanied by a statement in writing signed by him signifying his concurrence in the opinion signified in such resolution it shall be lawful for the Governor if it shall seem to him expedient so to do and with the advice and consent of the Executive Council of the Colony by Proclamation published in the New Zealand Gazette to declare that

And from and after the day appointed in such Proclamation all moneys payable to the Provincial Account or to the Provincial Treasurer of such Province or any other person for or on account of the revenue of such Province on any account whatsoever under or by virtue of "The Public Revenues Act 1867" or any Acts amending the 15 same or "The Payments to Provinces Act 1871" or any other Act of the General Assembly or under or by virtue of any Act or Ordinance of the Superintendent and Provincial Council of such Province shall until the end of the Session of the General Assembly aforesaid cease to be paid to such Provincial Account or Provincial Treasurer or other 20 person aforesaid and shall be payable and paid to the Public Account of the Colony to the credit of the Special Fund and shall be kept there at a separate account to be called "The Provincial Account of the " [naming the Province] and such moneys shall until Province of such day of the Session of the General Assembly aforesaid be charge- 25 able with all the costs charges and expenses of administering and managing the local government of such Province and the costs charges and expenses to be incurred in the exercise and performance of the powers and duties so transferred as aforesaid from the Superintendent of such Province to the Governor.

If the Provincial Council of any Province shall by resolution passed by a majority of the Members present at a meeting of such 35 Council signify its opinion that it is inexpedient for such Council to continue to provide or apply means to meet the expenditure necessary for the maintenance of the Gaols Police Crown lands Survey and Harbour Establishments within the Province and that all the powers and duties conferred or imposed on the Superintendent 40 of such Province either solely or with the advice and consent of the Executive Council of such Province relating to the administration or management of gaols police Crown lands surveys or harbours within such Province by any Act of the General Assembly or any Act or the Superintendent and Provincial Council of 45 Ordinance of such Province should cease to be exercised or performed by the Superintendent of such Province and if a copy of the resolution so passed be by the order of the Provincial Council of such Province forwarded to the Superintendent thereof and be afterwards transmitted to the Governor by such Superintendent accompanied by a statement 50 in writing signed by him signifying his concurrence in the opinion expressed in such resolution it shall be lawful for the Governor if it shall seem to him expedient so to do and with the advice and consent of the Executive Council of the Colony by Proclamation published in the New Zealand Gazette to declare that from and after a day to be named in such Proclamation all the powers and duties conferred or imposed on the Superintendent of such Province either solely or with the advice and consent of the Executive Council of such Province relating to the management and administration of the gaols police Crown lands surveys and harbours within such Province by any Act of the 60 General Assembly or any Act or Ordinance of the Superintendent and

Provincial Council of such Province shall cease to be exercised or performed by such Superintendent until the end of the Session of the General Assembly then next ensuing and shall be transferred to and con-

And from and after such day so appointed as in such Proclamation Superintendent's as in this section aforesaid all such powers and duties as in this section powers to cease. aforesaid shall until the end of the Session of the General Assembly aforesaid cease to be exercised or performed by such Superintendent and shall until the end of such Session be conferred and imposed on 10 the Governor.

And from and after the day so appointed in such Proclamation as Powers of Provincial in this section aforesaid and until the end of such Session of the General Assembly aforesaid all the powers duties and authorities of the Provincial Council with regard to gaols police and harbours within such 15 Province shall cease to be exercised or performed by such Council.

aforesaid and shall be payable and paid to the Public Account of the Colony to the credit of the Special Fund and shall be kept there at a separate account to be called "The Provincial Account of the Province " [naming the Province] and such moneys shall until such 30 of

day of the Session of the General Assembly in this section aforesaid be chargeable with all the costs charges and expenses of the administration management and maintenance of gaols and harbours Crown lands and surveys and of police and such other matters in connection there-

35 with within the said Province as may now by law be administered or managed by the Superintendent of such Province and the costs charges and expenses to be incurred in the exercise and performance of the powers and duties so transferred as in this section aforesaid from the Superintendent of such Province to the Governor.

And the issue and application of such moneys as aforesaid and all such costs charges and expenses as aforesaid shall from time to time

be authorized and regulated by the Governor in Council.

If the Governor shall so order there may from time to time be transferred to the Provincial Account of such Province from the 45 moneys so paid to the Special Fund any such sum or sums as are not in the opinion of the Governor likely to be required to meet such costs

charges and expenses as aforesaid. 4. If it shall be made to appear to the Governor in Council that in any Province sufficient and suitable provision is not made for the 50 maintenance of the Gaols the Police the Crown Lands Survey and Harbour Departments or any of them within such Province or that such Gaols or Police or Departments are not maintained in a proper state of efficiency the Governor in Council may cause a notice in writing under the hand of the Colonial Secretary to be sent to the Superintendent

55 of such Province declaring in what respects the provision for such department is defective and any other particulars which the Governor in Council may direct and such notice shall state what is required to be done or supplied to make good such deficiency.

5. If the Governor in Council at the expiration of

60 months from the delivery of such notice to the Superintendent is satisfied that all that was required by such notice to be done or supplied has not been done or supplied nor is in course of being

And from and after the day so appointed in such Proclamation as aforesaid and until such last day of the Session of the General Assembly aforesaid all the powers duties and authorities of the Provincial Council of such Province shall cease to be exercised or performed by such Council.

And from and after the day appointed in such Proclamation all moneys payable to the Provincial Account or to the Provincial Treasurer of such Province or any other person for or on account of the revenue of such Province on any account whatsoever under or by virtue of "The Public Revenues Act 1867" or any Act amending the same or "The Payments to Provinces Act 1870" or any other Act of the General Assembly or under or by virtue of any Act or Ordinance of the Superintendent and Provincial Council of such Province shall until such last day of the Session of the General Assembly aforesaid cease to be paid to such Provincial Account or to the Provincial Treasurer thereof or other person aforesaid and shall be payable and paid to the Public Account of the Colony to the credit of the Special Fund and shall be kept there at a separate account to be called "The Provincial Account of the Province of [naming the Province] and such moneys shall until such last day of the Session of the General Assembly aforesaid be chargeable with all the costs charges and expenses of administering and managing the local government of such Province and the costs charges and expenses to be incurred in the exercise and performance of the powers and duties so transferred as aforesaid from the Superintendent of such Province to the Governor.

Inquiry may be made by Commissioner with powers under "The Commissioners Powers Act 1867." And the issue and application of such moneys and all such costs charges and expenses as aforesaid shall from time to time be authorized and regulated by the Governor in Council.

6. The Governor in Council may at any time either before the giving of such notice or the making of such Order in Council as aforesaid cause an inquiry to be held into the condition and management of the Gaols and Police and the Land and Survey Departments within such Province by a Commissioner or Commissioners to be appointed by the Governor in Council: And such Commissioner or Commissioners shall for the purpose of such inquiry have all the powers and authorities conferred by "The Commissioners Powers Act 1867" or Commissioners appointed by the Governor in Council.

Powers transferred to Governor may be delegated. 7. It shall be lawful for the Governor in Council from time to time to delegate to such person or persons and subject to such restrictions and conditions as may seem fit all or any of the powers duties and authorities transferred to and conferred or imposed on him under or in pursuance of the sections of this Act except the power of authorizing and regulating such costs charges and expenses as are mentioned in the said sections respectively and in like manner to alter or revoke any such delegation.
