A BILL INTITULED

An Act to authorize the Sale of certain Public Re- Title. serves.

WHEREAS the lands described in the Schedules hereto have been preamble duly reserved for various purposes of public utility, and the said reserves are no longer required for such purposes: And whereas all the aforesaid lands are now vested in Her Majesty, and it is expedient that the same should be sold, or appropriated for other purposes respectively:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

10 1. The Short Title of this Act is "The Public Reserves Sale Short Title. Act, 1879."

2. The lands described in the First Schedule may, at any time Reserves in Schedules after the passing of this Act, be sold as town lands, suburban lands, to be sold or rural lands, upon such terms as the Governor in Council may 15 determine, after survey: Provided that such lands shall not be sold at a price less than lands of a similar class in the same district are

The lands described in the Second Schedule, which it was declared by "The Public Reserves Sale Act, 1878," should be sold as town 20 lands, may at any time after the passing of this Act be sold as suburban lands, upon such terms as the Governor in Council may determine, or may be set apart as sites for village settlements in pursuance of "The Land Act 1877 Amendment Act, 1879."

FIRST SCHEDULE. AUCKLAND.—WAIHERE LANDING-PLACE.

ALL that parcel of land being part of Maxwell's Claim, in the Parish of Waiheke, Waiheke Survey District, in the Provincial District of Auckland, containing twenty-three (23) acres, more or less. Bounded to the North-eastward by Sections 40, 42, and 43, Square 90; to the South-eastward by the River Hurunui; to the Southward by Section 1, Square 187; to the Westward by Section 278, Square 90; and to the North-westward by Sections 278, 287, 292, 291, and 293, Square 90: as the same is delineated on the plan deposited in the Survey Office, Nelson.

Also all that parcel of land in the Provincial District of Nelson, containing five hundred and forty-four (544) acres, more or less, being Sections 50 and 51, Square 90, in the Survey District of Mandamus.
