#### A BILL INTITULED

An Act to provide remedies against insider trading in the securities of public issuers, to require the disclosure of beneficial and other interests in the securities of public issuers, to regulate dealing in futures contracts, 5 and for those and other purposes, to amend the Securities Act 1978 and other enactments

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Securities Law Reform Act 1988.
- (2) Subject to **subsection (3)** of this section, this Act shall come into force on the date on which it receives the Royal assent.

Insider Trading

- 8. Liability of insider who deals in securities of a public issuer—(1) An insider of a public issuer who has inside information about the public issuer and who—

  (a) Buys securities of the public issuer from any person; or
- (b) Sells securities of the public issuer to any person—is liable to the persons referred to in subsection (2) of this section.
  - (2) The persons to whom the insider is liable are—
  - (a) In a case where the insider buys securities of the public issuer, any person from whom the securities are

bought for any loss incurred by that person in selling them to the insider:

(b) In a case where the insider sells securities of the public issuer, any person to whom the securities are sold for any loss incurred by that person in buying them from 5 the insider:

(c) The public issuer for—

(i) The amount of any gain made or loss avoided by the insider in buying or selling the securities; and

(ii) Any amount which the Court considers to be an 10

appropriate pecuniary penalty.

(3) The maximum amount for which an insider is liable under paragraphs (a), (b) and (c) (i) of subsection (2) of this section, combined, shall not exceed the greater of those separate amounts for which the insider is liable.

(4) The amount of any pecuniary penalty shall not exceed—

(a) The consideration for the securities; or

(b) Three times the amount of the gain made or the loss avoided by the insider in buying or selling the securities-

whichever is the greater.

(c) The total number of issued voting securities of the public issuer as at that date.

(2) Every other public issuer shall, not later than the 30th day of June in each year, send to every holder of its voting securities in New Zealand a notice showing, as at a date specified in the notice (but not a date earlier than 3 months before the date the notice is sent)—

(a) The names of all persons who, according to the file kept by it under section 26 of this Act, are substantial

security holders of the public issuer; and

Register of officers' shareholdings—(1) Every company shall keep a register in which shall be entered in relation to each officer of the company, the particulars contained in notices given by the officer under section 195 of this 25 (2) The register shall be— "(a) Kept at the company's registered office; and "(b) Open to inspection during business hours (subject to such reasonable restrictions as the company may 30 impose in its articles or in general meeting, so that not less than 2 hours in each day are allowed for inspection) by— (i) A member or debenture holder: "(ii) A person acting on behalf of the Registrar. "(3) The Registrar is entitled to be supplied with a copy of the register or part of it. '(4) A person who attends the company's annual general meeting is entitled to inspect the register at the meeting.

"(a) A requirement of this section is not complied with; or

- "(b) A person who is entitled to inspect the register is prevented from doing so; or
- "(c) The Registrar is not supplied with a copy of, or extract from, the register within a reasonable time—
  the company and every officer of the company who is in default commits an offence and is liable on summary conviction to a fine not exceeding \$1,000 and also to a further fine of \$100 for each day the default continues.

- "(a) A person entitled to inspect the register is prevented from doing so; or
- "(b) The Registrar is not supplied with a copy of, or extract from, the register within a reasonable time—
- 15 the Court may, on his or her application, order the company to allow the inspection or supply a copy of the register or extract from it.
