4. Section nine of the principal Act is hereby amended by repealing subsection one (as substituted by section four of the Supply Regulations Amendment Act, 1948), and substituting the following subsection:—

"(1) This Act shall continue in force until the 15 thirty-first day of December, nineteen hundred and fifty, and shall then expire."
