

STATUTES REPEAL BILL.

THE object of this Bill is to facilitate the work of the Commissioners appointed under the Reprint of Statutes Act, 1895—

(a.) By removing from the statute-book, by specific repeal, a number of enactments that from their nature would find no place in the consolidated statutes. With few exceptions these enactments are either—

(i.) Acts that have expired since the passing of the Statutes Repeal Act, 1902;

(ii.) Sections limiting the duration of an Act;

(iii.) Sections fixing the date of its commencement;

or

(iv.) Sections repealing an Act or section of an Act.

(b.) By repealing such of the Local and Personal Acts or parts of such Acts as are known to be spent or obsolete.

The completion of the work of the Commissioners will render necessary a reprint of the existing Local and Personal Acts, which now number 1,049; and as a very large number of these are spent or obsolete, a reprint of the whole as they now stand would mar the general usefulness of the undertaking.

As a preliminary to the preparation of the Schedule to the Bill, circulars were sent to the local authorities or persons interested in any Local or Personal Acts asking for a report on such Acts, with a view to their repeal, or partial repeal, or consolidation. Inquiry was also made with a like object of the heads of the various Departments concerned in the administration of any Local or Personal Acts. From the replies received to these circulars and inquiries the Schedule, so far as it relates to Local and Personal Acts, has been framed.

In no case has any Act or enactment been included in the Schedule contrary to the expressed wish of those interested in the Act or of those responsible for its administration.

This PUBLIC BILL, originated in the LEGISLATIVE COUNCIL, and, having this day passed as now printed, is transmitted to the HOUSE OF REPRESENTATIVES for its concurrence.

A BILL INTITULED

AN ACT for promoting the Revision of the Statute Law by repealing
Enactments which have ceased to be in Force or have become
unnecessary. Title.

5 WHEREAS it is expedient that certain enactments which may be
regarded as spent, or have ceased to be in force otherwise than by express
specific repeal by Parliament, or have by lapse of time or otherwise
become unnecessary, should be expressly and specifically repealed: Preamble

10 BE IT THEREFORE ENACTED by the General Assembly of New
Zealand in Parliament assembled, and by the authority of the same,
as follows:—

1. This Act may be cited as the Statutes Repeal Act, 1907. Short Title.

2. The enactments and parts of enactments described in the
Schedule hereto are hereby repealed. Repeals.

15 3. (1.) In any general reprint of Local or Personal Acts printed
under the authority of the Government there may be omitted all
enactments and words expressly repealed by this or any other Act,
whether before or after the passing of this Act; and there may be added
20 to such reprint a statement of such repeal and a reference to the
repealing Act; and, where necessary, there may also be added in italic
type any words expressly substituted by any such repealing Act in lieu
of any words so repealed. Reprint of Local
and Personal Acts.

(2.) Every copy of such reprint, or of any part thereof, purporting
25 to be printed under the authority of the Government by the Govern-
ment Printer shall be admitted as evidence thereof without proof that
such copy was so printed.

(3.) For the purposes of this section "Local and Personal Acts"
30 includes Provincial Ordinances, and any unrepealed enactment of a local
or personal nature in any Public General Act.
