A BILL INTITULED

AN ACT to amend "The Westland Churches, Schools, and Hospital Vesting Act, 1892." Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Westland Churches, Schools, and Hospital Vesting Act Amendment Act, 1893." Short Title.

2. Section (b) of subsection three of section two of "The Westland Churches, Schools, and Hospital Vesting Act, 1892," herein referred to as "the said Act," and also so much of the First Schedule of the said Act as defines a part of the Education Reserve numbered one hundred and twenty-eight (in red) as being set apart for a Roman Catholic Church, Presbytery, and School Reserve, is hereby repealed. Act of 1892 partly repealed.

3. Subject as hereinafter mentioned, the School Commissioners for Westland are hereby authorised to convey in fee-simple the land described in the Schedule to this Act to the Right Reverend John Joseph Grimes, Doctor of Divinity, Roman Catholic Bishop of Christchurch, and his successors, as a site for a church, presbytery, and boys' school, in consideration of the sum of twenty-eight pounds sterling. Amended description of reserve made for Roman Catholic purposes at Kumara.

SCHEDULE.

KUMARA RESERVE FOR ROMAN CATHOLIC PURPOSES.

ALL that piece or parcel of land containing by admeasurement 3 acres 2 roods, more or less, being part of Education Endowment No. 128 (in red), Block XII., on the map of the Waimea Survey District, and comprising Subdivisions Nos. 632, 633, 634, 635, 636, 637, 638, 639, 640, 641, 642, 643, 644, 645, 646, 647, 648, 649, 678, 679, 680, 681, 682, 683, 684, 685, 686, and 687, of the portion of the Town of Kumara in the said reserve. Bounded towards the north-east by Tui Street; towards the south-east by Fourth Street; towards the south-west by Town Belt South; towards the north-west by Third Street; and which said piece or parcel of land is delineated on the map showing the town sectional subdivision of the Kumara portion of the said Reserve No. 128 (in red).
