A BILL INTITULED

An Act to reserve Land as an Endowment for the Wairoa Harbour Title. Board.

WHEREAS the Wairoa Harbour Board is a duly constituted Preamble. 5 Harbour Board constituted originally under and by virtue of the Wairoa Harbour Board Act, 1878, and now constituted under the Wairoa Harbour Board Empowering and Loan Act, 1909, and the Harbours Amendment Act, 1910: And whereas it is expedient that the lands described in the Schedule hereto should be vested 10 in the said Board for the purposes and with the powers hereinafter mentioned:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

15 1. This Act may be cited as the Wairoa Harbour Board Endow- Short Title. ment Act, 1916.

2. The lands described in the Schedule to this Act are hereby Land set aside as set aside and reserved as an endowment for the Wairoa Harbour endowment. Board for the purposes of the Harbour and Port of Wairoa generally, 20 including therein the improvement of the said port and harbour.

3. The said lands are hereby vested for an estate in fee-simple Land vested in in the Wairoa Harbour Board for the purposes declared in the Board. last preceding section hereof and freed and discharged of and from all trusts or reservations now or heretofore affecting, or declared 25 of, or concerning the same, save and except any rights of road

which may now be subsisting over or in respect of the same.

4. The said Wairoa Harbour Board shall have and may exercise Leasing powers. in respect of the said lands, or any part or parts thereof, all leasingpowers for the time being vested in Harbour Boards and in particular 30 the powers conferred by section thirty-eight of the Harbours Amendment Act. 1910.

Repeal.

5. So much of section thirty-one of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1915, as declared the said land to be Crown land available for disposal under the Land Act, 1908, and the provisoes to subsection one of the said section thirty-one of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1915, are hereby repealed, but without prejudice to the right of the said Board to claim and to be paid any moneys accrued or accruing at the date of the coming into operation of this Act under the first of the said provisoes.

Act to be deemed a special Act.

6. This Act shall be deemed to be a special Act within the 10 meaning of the Harbours Act, 1908.

ALL that area in the Hawke's Bay Land District, containing by admeasurement 951 acres 3 roods 24 perches, more or less, being part of Section 21, Block XII, Taramarama Survey District: bounded towards the north by Section 125, Block VIII; towards the east by Mangaruhe No. 1 Block and Section 20, Block XII aforesaid; towards the south generally by other part of the said Section 21 as described in the New Zealand Gazette No. 43 of the 30th day of April, 1914, page 1586, and Section 28, Block XII aforesaid; and towards the west by Section 35 in Blocks VIII and XII aforesaid.
