A BILL INTITULED

AN ACT to enable the Governor to grant Lands on the Foreshore of the Waitara River to the Waitara Harbour Board, and to empower the said Board to borrow Money for Harbour Works. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

The Short Title of this Act is “The Waitara Harbour Board Land and Borrowing Act, 1879.”</p> <p>2. “The said Act” means “The Harbours Act, 1878.” “Board” means the Waitara Harbour Board constituted under the said Act.</p> <p>3. It shall be lawful for the Governor to issue a grant to the Board of the lands described in the Schedule hereto in trust for harbour purposes.</p> <p>4. The lands hereby authorized to be granted to the Board, having a frontage on tidal water, shall be deemed to be a wharf within the meaning of the said Act.</p> <p>5. SCHEDULE.

Schedule.

ALL that parcel of land in the Provincial District of Taranaki, in the Town of Raleigh East, containing by admeasurement two hundred and thirty-eight (238) acres, more or less. Bounded towards the West by low-water mark of the Waitara River from the bridge across that river (opposite Section No. 10) to its mouth; thence towards the North by low-water mark of the ocean to where the eastern boundary line of Section No. 37, Waitara East District, produced, intersects it; towards the East by that line; towards No. 47—1.

the South by Sections Nos. 37, 36, 35, and 34, of said Waitara East District; again towards the East by said Section No. 34 to Waahi Road; again towards the South by the Waahi Road aforesaid; again towards the East by East Quay, which is one hundred (100) links wide, to the western boundary of a street at the bridge aforesaid, thence by that street to the starting point.

Also all that other parcel of land in the Provincial District of Taranaki, in the Town of Raleigh West, containing by admeasurement one hundred and fifty (150) acres, more or less. Bounded towards the North and East by the New Plymouth Harbour Endowment and low-water mark of the Waitara River; towards the South by said low-water mark, a stream, and a swamp, to Nelson Road; towards the West by Nelson Road aforesaid; again towards the North by Brooke's Terrace, which is one hundred (100) links wide; again towards the West by West Quay, which is one hundred (100) links wide, and Queen Street, which is one hundred and fifty (150) links wide; towards the South-west and again towards the South by Battiscombe Terrace, which is one hundred (100) links wide, and Brown Road; and again towards the West by Section No. 1, Waitara West District, to the sea at high-water mark: save and excepting the road one hundred links wide leading to the bridge hereinbefore mentioned.

Also all that other parcel of land in the Provincial District of Taranaki, in the Town of Raleigh East, being Section No. 2, Block XIX., of said town, and containing by admeasurement one (1) rood, more or less. Bounded towards the North-west by Gold Street; towards the North-east by Leslie Street; towards the South-east by Section No. 4, Block XIX. aforesaid; and towards the South-west by Section No. 1, Block XIX.

Also all that other parcel of land in the Provincial District of Taranaki, in the Town of Raleigh East, being Sections Nos. 10 and 11, Block XIX., of said town, and containing by admeasurement two (2) roods, more or less. Bounded towards the North-west by Sections Nos. 8 and 9, Block XIX. aforesaid; towards the North-east by Leslie Street; towards the South-east by High Street East; and towards the South-west by East Quay.

Also all that other parcel of land in the Provincial District of Taranaki, in the Town of Raleigh East, being Sections Nos. 7, 8, 9, 10, 11, 12, and 13, Block XXVII., of said town, and containing by admeasurement one (1) acre three (3) roods three (3) perches, more or less. Bounded towards the North-west by Section No. 5, Block XXVII. aforesaid; towards the North-east and again towards the North-west by Section No. 6, Block XXVII. aforesaid; again towards the North-east by Leslie Street; towards the South-east by Carey Street; and towards the South-west by East Quay.

Also all that other parcel of land in the Provincial District of Taranaki, in the Town of Raleigh East, being Sections Nos. 1, 2, 3, 4, 5, 6, 7, 8, and 9, Block XXXVI., of said town, and containing by admeasurement two (2) acres one (1) rood nine (9) perches, more or less. Bounded towards the North-west by Carey Street; towards the North-east by Leslie Street; towards the South-east and again towards the North-east by Section No. 10, Block XXXVI. aforesaid; again towards the South-east by Section No. 11, Block XXXVI. aforesaid; and towards the South-west by East Quay: as the said several parcels of land are delineated on the plans deposited in the Survey Office, New Plymouth.
